MINUTES OF MEETINGS

Meeting of District Quality Assurance Committee (DQAC) was held on 05/12/19 at 11:00 a.m. in the office of the District Magistrate (South East District) under the Chairmanship of DM SED.

3. STERILIZATION FAILURE CASE

(A) After introduction sterilization failure case reported from Parivar Seva Sanstha, Lajpat Nagar was discussed as per details given below:

CURRENT MEDICAL HISTORY

Client came to ParivarSeva on 02/4/19 with suspected pregnancy which was confirmed by ultrasound report done on 02/4/19.

On Examination : Gestational age was 15 weeks 5 days and Patient was advised

for MTP.

Date of MTP Procedure : 04-04-19

Name of Obstetrician: Dr Neha

Name of Place : Parivar Seva, Lajpat Nagar, Delhi

Obstetric History : G5P3A1

Clinical Record : Physical Examination – PR-82/m; BP – 110/70

Systemic Examination - Normal

Per Speculum Examination : Cervix normal clear

Bi-Manual Examination: Cervix – Soft, No Tenderness; Os – Closed

Uterus - 16-18 weeks; AV, Shape- regular

Adnexae - Tenderness - No

Palpable Mass - No

Investigation: Hb - 10.3g %; Albumin Sugar - Nil

The pregnancy was terminated on 04/04/19 in the facility.

On 07-05-2019, Contraceptive IUCD inserted.

(B)In view of non availability of documents for verification, a letter received from Parivar seva confirmed the information regarding MTP followed by sterilization procedure of beneficiary Ms Meena which was based on the copy of their prescription dated 25/10/2004 and the certificate of sterilization issued by them

(C)They also stated that the original documents for verification are unavailable as they maintain sterilization records for 8 yrs.

(D)After submission of all the relevant document to the DQAC Members the committee was of the opinion that case may be forwarded as per the provision of FPIS

(E)Further it was decided to issue directives to Parivar Seva to keep all documents pertaining to sterilization procedure indefinitely (Digitalization of the documents can be sorted as an option so as to ensure that all the information and data can be kept indefinitely)

(F)DQAC members were informed regarding the payment of about Rs 60000 which has already been done to previous sterilization failure case Mrs Manju.

4. PPIUCD AND PAIUCD EMPANELMENT

(A)The discussion on PPIUCD Empanelment was done. All the necessary qualification and requirement was discussed. Following doctor and nursing personnel have been approved by the members.

(B)Further discussion on PAIUCD Empanelment was done. All the criteria were discussed. All the submitted documents were scrutinized by the DQAC members and following doctors have been approved for PAIUCD Empanelment

5. DISCUSSION ON PARIVAR SEVA VISIT

The members were informed that district DLMC team, DAC team and DAC for MTP conducted their visit on 30.1.19 and have submitted their report. It was decided that the DQAC members will visit the facility again and check for the compliance pertaining to all the recommendation suggested by team which visited on 26/09/18.

- 6. The DQAC Members were informed that district south east has 11 centers who have been empanelled for sterilization services but regular monitoring of the sterilization centers was not being done. The members were of the opinion that visit should be planned and conducted regularly. Decision to plan the visit in month of feb was made and date to be intimated to all members once decided
- 7. Empanelment of Apollo Cradle Hospital, Nehru Enclave, CR park, New Delhi .
 In DQAC held on 20.11.2017 it was decided not to accredit the facility due to failure to comply with the recommendations suggested by the visiting team. They have resent the application for empanelment on 27/11/19 again. The committee decided to visit the centre again and reconsider their application.
