Sterilization Failure case of Nisha Kumari w/o Pappu Mandal: - All the documentation verified by district team and case forwarded to SISC for compensation.

Regarding sterilization failure case of Nisha Kumari w/o Pappu Mandal:-

- Nisha Kumari underwent Lap Ligation on 13.02.2020 at GGSGH. The claimant reported to GGSGH with UPT +ve report dated 31.03.2021. Her Ultrasound was done on 03.04.2021 Shows SLIP with 7 weeks pregnancy.
- Her MTP with IUCD 380A was done on 13.04.21.
- As per DISC comments: Earlier patient had laparoscopic sterilization, on failure opted for MTP with IUCD insertion. As repeat surgery was not done cause of failure cannot be ascertained.
