DQAC Minutes of meeting

A meeting of District Quality Assurance Committee (South – West District) was convened on 20/07/20 at 03:30 pm under the Chairmanship of CDMO, South West District as directed by DC,SWD(Revenue) in the office of DPMU South West, Sec 10, Dwarka, Delhi.

The meeting was attended by following members: -

Agenda of the meeting was as follows: -

1. Empanelment of Doctors for PPIUCD, PAIUCD and Male & Female Sterilization services.
2. Three cases of ligation failure reported from RTRM Hospital and SDDMASC.
3. Discussion of any other issue with the permission of Chair.

The meeting started with a welcome address by RCH Nodal Officer, Dr.Devalina Sikdar. She then outlined the **First agenda** for the meeting i.e Empanelment of 8 Medical Officers for family planning services out of which 3 for PPIUCD and 5 for PPIUCD, PAIUCD and Minilap.

The committee members checked all the applications and documents submitted for empanelment as per guidelines and unanimous approval was given to all the 8 applicants for empanelment.

The RCH Nodal Officer was directed to prepare empanelment certificates and send to SDDMASC (where all the above mentioned residents are posted) at the earliest.

2nd Agenda

The discussion of all three ligation failure cases reported from RTRM Hospital and SDDMASC Hospital were carried out in detail by committee members :-

- i) Ms. Shobha w/o Mohan Lal whose ligation was done on 22/5/2014 at RTRM Hospital and failure reported on month 16/03/2020.
- ii) Ms. Poonam w/o Mahender Singh whose ligation was done on 13/4/2017 at SDDMASC and failure reported on 04/06/2020.
- iii) Ms. Vimmy w/o Shekhar whose ligation done on 22-01-2020 at SDDMASC Hospital and failure reported on 23/04/2020.

Committee members checked all the documents and certificates submitted for claim of compensation amount as per guidelines and unanimously approved the claim for payment of compensation money to clients.

Committee members stressed on regular quality checks to improve sterilization services with a view to reduce ligation failure cases.

RCH Nodal officer Dr. Devalina Sikdar put forward the request that SDDMASC and RTRM Hospital should resume sterilization services (Female Sterilization and NSV) after rapid antigen test of beneficiaries.

Dr. Ritika Anaesthetist from SDDMASC agreed to resume Minilap sterilization services if MS Dr. Brijesh gave permission but raised concerns about Lap ligation as the procedure generates more aerosols.

Dr. Kamal Kishor Gautam NSV surgeon, RTRM H also agreed to resume NSV services after normal OT services had resumed in RTRM Hospital. He pointed out that at present RTRM H had inadequate staff due to COVID-19 detailments.

The meeting ended with a vote of thanks


