In the said meeting following points discussed and also recommended by the committee:-

- 1. It has been observed that failure cases are being reported within first 6 months of sterilization which raises questions over quality in the programme. Hence committee is of the view that all the cases done by newly empanelled doctors must be supervised by experienced service providers.
- 2. HSG should be done in all cases of doubt and should be covered by additional contraceptive till the availability of the report.
- 3. Case sheets claim forms and Consent Forms are not properly filled and also not counter signed by facility Family Planning Nodal Officer. No column should be left blank.
- 4. All the facilities must have provider wise record of number of sterilization procedures and number of failure cases for submitting it to the district during DQAC for analysis.
- 5. All the failure cases must be discussed by Facility Quality Assurance Committee and minutes shared with the District regularly for ready reference during DQACs.

The meeting ended with the vote of thanks to the chair.
