MINUTES OF MEETING

The 1st District Quality Assurance Committee (DQAC) meeting of F.Y 2019-20 was held on 06.07.2019 in the O/o DC west, Rajouri garden under the chairmanship of ADM, WD. The meeting was attended by the following:-

The meeting started with a welcome note by RCH Nodal Officer and a round of introduction.

The agenda of the meeting was:-

1. To discuss two sterilization Failure Cases from different hospitals.
2. To discuss empanelment of new doctors of different hospitals of west district.
3. To Review the failure case of Mrs. Hemlata w/o Mahender Kumar Meena

Regarding Sterilization failure case of Hemlata w/o Mahender Meena:- The case was discussed in last DISC meeting dated 12.3.2019 and was recommended by the DISC members for onward submission to DFW for claim settlement.

The case was reverted back to the district with the comment to seek clarification regarding time frame for filling the claim with respect to the current guidelines. As the claimant reported to Jag Pravesh Chandra Hospital at 10 weeks on 4.7.2018, Pandit Madan Mohan Malaviye Hospital on 2.11.2018 with 28 weeks pregnancy and DDU Hospital on 28.11.2018.

The case was discussed and DQAC members are of the view that the records of both the above said hospitals required from the claimant.

Regarding Sterilization failure case of Reshma w/o Rahish:- Claimant is 36 years old. She had undergone MTP followed by Lap Ligation in GGSGH, Raghbir Nagar on 4.7.2018. The pregnancy was detected on 3.1.2019 with UPT +ve and P/A - 8 to 10 weeks. Her USG was done on 3.1.2019 itself and showed 8 weeks 6 days single live intra uterine pregnancy. Her MTP followed by MPA injection was done on 5.1.2019.

The case was discussed among DQAC members. Since the patient did not opt. for re sterilization the reason for failure cannot be commented upon. All the documents were found appropriate. DQAC members recommended the case for compensation.

Regarding Sterilization failure case of Rekha w/o Ram bali:- Claimant is 31 year old female. She got her MTP with diagnostic lap with minilap with bilateral tubal ligation on 13.8.2018 at GGSGH, Raghbir Nagar. She reported back to GGSGH with UPT +ve on 2.3.2019, P/v - uterus bulky. Her findings of USG dated 2.3.2019 were suggestive of ectopic pregnancy. Case was referred to DDUH, Hari Nagar. Her exploratory laprotomy with right salpinxectomy was done on 2.3.2019 at DDUH.

The case was discussed in DQAC meeting as per discussion the right sided tube was already ruptured and the ligation site was properly visualized. On left side dense adhesions were present in adnexa only initial portion of the tube could be visualized. Previous ligation site not seen therefore reason seems to be inherent recanalization. All the documents were found appropriate. DQAC members recommended the case for compensation.

Regarding PAIUCD empanelment:- Total 5 applications were received. The details are as under:-

ESI- 3 SRs and 1 Professor and Head academics (all the applicants recommended for empanelment).
ASBGH - 1 Medical Officer (all the applicants recommended for empanelment).

The DQAC members checked documents of all applicants and approved empanelment of all 10 applicants.

Regarding PPIUCD empanelment:- The DQAC has received total 11 applications of 8 SRs and JRs. Details are as under:-

DDUH - 1SRs, 1 DNB and 2 JRs (all the applicants recommended for empanelment).
ESI- 3 SR (all the applicants recommended for empanelment).
ASBGH - 3 SRs and 1 JR (all the applicants recommended for empanelment).


Regarding Sterilization empanelment:- Total 8 application were received . The details are as under:-

ESI – 2 SRs and 1 Professor and Head Acadmic (2 applications for Minilap and 1 application for Minilap + lap Ligation)
2 applicants were recommended for empanelment and but the empanelment of Dr Anil Kumar (SR) for Minilap is subjected to submission of experience certificate.

DDUH - 2 SRs applications for Minilap were received and both were recommended for empanelment.

ASBGH – 3 SRs applications for Minilap were received all the three cases were rejected due to inadequate documentation.
