Following decisions were taken:

**Agenda 1: Action plan for reduction of IMR to less than 10:** As per the target set for Delhi, the infant mortality rate needs to be reduced to less than 10.

Executive Committee directed that the State Program Officer (Child Health) may share the action plan with all the members. The details may be discussed in another meeting to be convened under the Chairmanship of Pr. Secretary, H&FW, GNCTD. {Action: State Program Officer (Child Health)}

**Agenda 2: Action plan for improvement of Sex ratio:** State needs to ensure that the sex ratio is improved.

Executive Committee directed that the State Program Officer (PC & PNDT) may share the action plan with all the members. The details may be discussed in another meeting to be convened under the Chairmanship of Pr. Secretary, H&FW, GNCTD. {Action: State Program Officer (PC & PNDT)}

### Agenda 4: Post Creation of employees under Delhi State Health Mission

There are various posts of Medical, Nursing, Para-medical, Administrative, Technical and Support Staff under Delhi State Health Mission. These staff are deployed in Management Units and Seed Primary Urban Health Centre under the Mission, Delhi Govt. Hospitals ,Delhi Government Dispensaries, Central Govt. Hospitals, Central Govt. Primary Health Centre, Chest Clinics, health facilities of East, North and South MCD's, health facility of New Delhi Municipal Council and other bodies like Northern Railway Hospital, Delhi Cantonment Board Civil Hospital, Autonomous Body like AIIMS & Safdarjung, NGOs like Rama Krishnan Mission and Dr. Shroff's Charity Eye Hospital.

Executive Committee approved that the administrative in charges may be requested for post creation as per the place of posting of these contractual engagement in Directorate of Health Services, GNCTD, Delhi Govt. Hospitals, East Delhi Municipal Corporation, South Delhi Municipal Corporation, North Delhi Municipal Corporation, New Delhi Municipal Council, Delhi Cantonment Board & Central Govt. **{Action: SPO (DSHM)}** 

### Agenda 5: Release of pending dues of State Consultant, NTCP.

Mr. Prasanta Konar was appointed as State Consultant on contractual basis for National Tobacco Control Programme by Ministry of Health and Family Welfare in May 2010. The order regarding continuation of services of State Consultant was received yearly from the Ministry of Health and Family Welfare.

National Tobacco Control Programme (NTCP) was merged with DSHM for the first time in F.Y 2015-16. The post of State Consultant was not approved in the administrative approval of State Program Implementation Plan and Supplementary PIP 2015-16 and he was asked to discontinue.

The services of the State Consultant were continued as ongoing by the SPO, NTCP from 1st April 2015 to 6th August 2015 for which his monthly remuneration has not been paid due to non-receipt of approvals in PIP 2015-16.

Executive Committee directed that the proposal may be submitted to Chairman, SHS (D) on file. **{Action: SPO (NTCP)}** 

#### Agenda 6: Placement of Leprosy Assistants:

The posts of Leprosy Assistants were approved for Delhi on Pilot basis where they assisted the Dermatologists in Secondary and tertiary hospitals of Delhi in suspecting the cases, maintenance of records, counselling, follow up and continuation of treatment.

State Leprosy Officer has received an OM dated 8.5.2018 vide File No Z-14020/13/2017- Lep.I/3154641/2018 from Govt. of India in which it has been mentioned that "Positions of Leprosy Assistants may be discontinued. Further it is stated that the scheme may not be continued in its current form. The proposal may be considered if the State Government proposes to position the additional human resource in the urban PHCs under NUHM.

Executive Committee directed that the services of Leprosy Assistant may be discontinued as per the terms & conditions of the contract under Delhi State Health

#### Agenda Point No. 7:- Submission of State PIP 2018-19

As per approval from State Health Society (Delhi), 1st draft of State PIP 2018-19 was submitted to Government of India on 09/03/2018. As per preliminary observations received from respective program divisions, 2nd draft was submitted on 22/05/2018.

NPCC meeting for discussion of State PIP 2018-19 was held on 16/04/2018 under the Chairmanship of AS & MD, NHM, MoHFW, GoI. In line with the discussion held during the meeting, the State Program Implementation Plan was revised based on the inputs received from State Program Officers with the approval of their administrative in charges.

Following proposals which were included / modified after submission of first draft to the Governing Body of State Health Society (Delhi) was submitted to the Executive Committee:

(i) **Proposal for Integrated Initiative for Prevention and Control of Viral Hepatitis:**- As per the guidelines received from the MoHFW, GoI, the proposal with a financial implication of Rs. 719.05 Lakh has been included. This includes Rs. 684.46 Lakh for the drugs for Hepatitis-C which will be supplied by Ministry in kind along with support to the identified centre i.e. Lok Nayak Hospital as per Annexure - 2.

Executive Committee approved the proposal.

(ii) National Leprosy Eradication Program:- A pilot project for prevalence study of leprosy in Shahdara and South West District with a financial implication of Rs. 97 Lac has been included under innovations

Executive Committee directed that an IEC campaign should be strengthened. Since, the rate of grade II physical deformity is high for Delhi mapping of these cases may be done. **{Action: SPO (NLEP)}** 

- (iii) National Program for Control of Blindness (NPCB):- Executive Committee approved the proposal for NPCB as per new norms received from MoHFW, Govt. of India.
- (iv) National Program for Prevention and Control of Cancer, Diabetes, Cardiovascular disease and Stroke:- Executive Committee approved the revised proposal to include South, South East, South West and Shahdara for universal screening for Non Communicable Diseases besides Central District.
- (v) **Immunization:** Proposals for immunization have been revised. A proposal for Human Resource for implementation as per following details has been included:-

Cold Chain Technician @ Rs.37,290/- per month

Sr. Project Officer @ Rs.185729/- per month

Project Officer @ Rs.1,55,914/- per month



Project Officer Operations @Rs.1,26,099/- per month:

Executive Committee directed that the State Immunization Officer should inform the qualification and job responsibility of the proposed positions to the committee constituted under Delhi State Health Mission for finalization of recruitment rules to decide the monthly remuneration which may be paid to these positions.

Executive Committee approved the proposal for additional funds of Rs.328 Lac for MR Campaign in the current financial year 2018-19.

- (vi) Maternal Health:- (a) Proposal for setting up of high dependency unit & intensive care unit in Safdarjung Hospital, Guru Tek Bahadur Hospital, Smt. Sucheta Kriplani Hospital, Dadadev Matri avam Shishu Chikitsalaya, Lal Bahadur Shastri Hospital and Lok Nayak Hospital with a financial implication of Rs. 11.39 Crores has been included (Annexure-3)
- (b) Proposal for human resource for strengthening of labour room at Pt. Madan Mohan Malviya Hospital and Deep Chand Bandhu Hospital with a financial implication of Rs. 208.62 Lakh has been included (Annexure-4).

Executive Committee directed that the human resource may preferably be taken up from the respective organizations.

- (vii) National Urban Health Mission: Following proposals were approved by Executive Committee:-
- a) Enhancement of Untied Grant to PUHC to include existing Aam Aadmi Mohalla Clinic @ Rs. 50,000 per facility.
- b) Proposal for AADHAR based biometric attendance machine / biometric attendance machine for all facilities where contractual engagements under DSHM are placed with a financial implication of Rs. 32.40 Lakhs.
- c) Health & Wellness Centre: 57 Delhi Govt. Dispensaries shall be upgraded to ensure that all the services of Health and Wellness Centre's as per following details are provided:-
- 1. Care in pregnancy and child-birth.
- 2. Neonatal and infant health care services
- 3. Childhood and adolescent health care services.
- 4. Family planning, Contraceptive services and Other Reproductive Health Care services
- 5. Management of Communicable diseases: National Health Programmes
- 6. General out-patient care for acute simple illnesses and minor ailments
- 7. Screening and Management of Non-Communicable diseases
- 8. Screening and Basic management of Mental health ailments
- 9. Care for Common Ophthalmic and ENT problems
- 10. Basic Dental health care
- 11. Elderly and palliative health care services
- 12. Trauma Care (that can be managed at this level) and Emergency Medical services

To ensure that all the 12 services are provided in H&FW Centre's, the medical officer need to be trained in:

- i. Screening and basic management of Mental illness.
- ii. Provision of Basic Dental Services
- iii. Basic geriatric care

No funds have been sought for upgradation of dispensaries to Health & Wellness Centre.

d) Quality Assurance Coordinator, one for each district was already approved in PIP 2017-18 @ Rs. 35,000/- per month. They are yet to be recruited. In the RR review exercise, their RRs were matched with the GoI RRs has been approved by the designated Committee. Accordingly the provisions sought in current PIP enhanced to Rs. 40,000/-per month.

#### Agenda Point No. 8:- Financial Progress under National Health Mission

Empowered Committee was informed the financial progress for the year ending 31.03.2018 as per -5.

#### Agenda 9: Status of statutory audit 2017-18

Empowered Committee was informed that the statutory Audit for 2017-18 for the 11 Integrated District Health Society has been completed. Statutory Audit for the State Units is under progress. It is expected that the Statutory Audit report will be finalized by 31.07.2018 as per the timelines set up by MoHFW, GoI.

Empowered Committee was informed that Dr, Praveen Kumar, Addl. Project Director (DSACS) has been nominated as Nodal Officer-Voluntary Blood Donation & Dr. Suresh Kumar, Medicine Department, Lok Nayak Hospital has been nominated as Nodal Officer for Integrated Initiation for Prevention and Control of Hepatitis.

A proposal for creation of new budget head under Detailed Demand for Grants for National Urban Health Mission 2018-19 has been submitted for a budget estimate of Rs. 70 Crores.
