**WALK – IN- INTERVIEW FOR THE POST OF JUNIOR RESIDENT ON Ad-Hoc BASIS TO BE HELD ON
20/12/2022.**

Deep Chand Bandhu Hospital invites applications for a Walk-in-interview for filling up **(02) Two vacant post of Junior Residents Doctors on Ad-hoc basis**. Only candidates who fulfill the eligibility criteria as per Residency Scheme may appear before the interview panel on **20/12/2022** 9:30 AM to 11:00 AM with their original documents.

Note:- Submission of application will be 09:30:AM to 11:00AM on-20 /12/2022 Room No.3002, 3rd Floor, Administration Branch, DCB hospital.

Qualification: MBBS Degree from a recognized University/Institution and must possess valid Registration Certificate from DMC.

Internship: Candidates who have completed internship earlier than 2 year at the time of interview shall not be eligible.

Pay Scale: Pay of Rs. 56100/- as per 7th CPC level 10 plus allowances as admissible under the rules.

Age: 30 years for General, 5 years relaxable for SC/ST and 03 years for OBC candidates (belonging to Delhi only) on the closing date of submission of application.

Tenure:- The Maximum tenure of Junior Residents(MBBS) is for a period of one Year only including any service rendered as Junior Resident earlier on ad-hoc/regular basis in any recognized institution. The appointment will be initially for 89 days or till joining of regular junior Resident whichever is earlier. That can be extended further up to a maximum period of 01 year subject to satisfactory performance, work and conduct report from concerned HOD.

Relaxation of provision as per circular No. F.121/26/2010/H&FW/1996-2045 dated 10.06.2011 of Deptt. of H&FW, GNCT of Delhi. If the fresh candidate is not available then following relaxation may be applicable:-

1. Upper age limit for eligibility for JR will be 40 years.
2. In case of non availability of fresh candidates, candidates who have completed one year Residency as J.R. may also be allowed to appear in the interview.
3. Separate merit lists for fresh candidates and for others (i.e. those who have already completed one year Junior Residency) would be prepared.
4. Firstly, the list containing the names of fresh candidates would be exhausted for appointment and the second list would be used only after that.

5. Reservation of Person with Disability will be as per Government Rules.


Other conditions/requirements:-

- i. **Hostel accommodation is compulsory.**
- ii. The candidates who are already in govt. service should submit an NOC from his/her Employer.
- iii. The services of Junior Residents shall be governed by residency schemes of Govt. of India/Civil Services (Temporary Rules).
- iv. Candidates are required to bring all original certificates and testimonials along with two passport size photographs on the date of interview.
- v. Appointment shall be subject to medical fitness & verification of certificates.
- vi. No TA/DA will be paid for appearing in the interview.
- vii. Reservation of Person with Disability will be as per Govt. Rules

Submission of application:


Interested and eligible candidates may apply in the prescribed format with self attested copies of all testimonials and certificate i.e list of documents Date of birth certificate (Metric Certificate), MBBS, Internship Certificate, Degree/Diploma, Caste Certificate DMC registration Certificate and Proof of Permanent Address. Application after 11:00 AM will not entertain.
