A virtual meeting of District Indemnity Sub Committee(DISC),South – West District was convened under the Chairmanship of DM, South West District(Revenue) on 28/06/2021 at 12:00 pm.

The meeting was attended by following members: -



Agenda of the meeting: -

1. Virtual DISC Monitoring of DGHC Sec-2 Dwarka
2. Certification for PAIUCD, PPIUCD, Minilap and Laparoscopic Sterilization Empanelment requests received from SDDMASC and RTRM Hospital.
3. Any other issue with the permission of the chair.

- The meeting started with a welcome address by CDMO, SWD, Dr. Anjana Kaushal. RCH Nodal Officer, Dr. Devalina Sikdar then outlined the **First Agenda** of the meeting that was - **Virtual DISC Monitoring of DGHC Sec-2 Dwarka** and raised concern about poor family planning services and no interval IUCD insertion was done in DGHC Sec-2 Dwarka in the last 6 months.
- MOIC DGHC Sec-2, Dwarka, Dr. Kamna Agarwal replied that due to covid vaccination, testing and containment zone monitoring, follow-up of family planning services were hampered and promised to resume all family planning services with full function.

- CDMO, South-West, Dr. Anjana Kaushal stressed on follow-up of family planning beneficiaries by their ASHAs and need to resume full counselling of beneficiaries as there is low Covid-19 positivity rate now.
 - Dr. Vivek Ranjan, Specialist gynae, SDDMASC stressed on proper examination and documentation of all findings (BP, Weight, Height, Hb etc) of ANC cases also by health facilities prior to sending to hospital.
 - Dr. Kamna Agarwal, MOIC, DGHC Sector-2, Dwarka, was told to send all FP registers to DPMU, Sec-10, Office for checking.
 - **RCH Nodal Officer, Dr. Devalina Sikdar outlined the 2nd agenda of meeting that was - Certification for PAIUCD, PPIUCD, Minilap and Laparoscopic Sterilization Empanelment requests received from SDDMASC and RTRM Hospital.**
 - The committee members checked all the applications and documents submitted for empanelment as per guidelines. It was found that two Medical officers – Dr. Eram Ali from RTRMH And Dr. Shruti Bajpai from SDDMASC who had applied for empanelment, did not have valid DMC registration(expired), so conditional approval was given to these two Medical Officers for empanelment subsequent to Submission of valid DMC certificate within 30 days, if not submitted within 30 days, applicants are advised to re-submit the applications.
 - Unanimous approval was given to all other 5 medical Officers for empanelment.
 - Family Planning Nodal Officers RTRMH & SDDMASC were instructed to submit valid DMC registration of these two Medical Officers at the earliest.
 - The RCH Nodal Officer was directed to prepare empanelment certificates and send to SDDMASC at the earliest.
- The meeting ended with a vote of thanks.
