MINUTES OF DOAC MEETING

A MEETING OF DISTRICT QUALITY ASSURANCE COMMITTEE ON FAMILY PLANNING, NORTH EAST DISTRICT HELD ON 03TH SEPTEMBER 2019 AT 03:00 PM AT D.M. CONFERENCE HALL, K-BLOCK, D.C. OFFICE COMPLEX, NAND NAGRI, DELHI-93.

At the outset, Mission Director, North East District, welcomed the members. After brief round of introduction, the proceeding of meeting started.

The proceeding and decisions are recorded as under:-

- Empanelment of various Doctors of Jag Pravesh Chandra Hospital for sterilization procedure was discussed. The guideline/criteria required for empanelling the doctor for sterilization (Female) procedures was discussed with committee members. The recommended list for empanelment of doctors from district Hospital for Mini Laparotomy Sterilization was shared. All members of Committee unanimously decided that doctors as per enclosed list be empanelled.
- Recommended list of doctors for Post Partum Intrauterine Contraceptive Device (PPIUCD) empanelment of JPC Hospital was also shared. All members of Committee unanimously decided that doctors as per enclosed list be empanelled.
- Recommended list of doctors for Post Abortion Intrauterine Contraceptive Device (PAIUCD) empanelment of JPC Hospital was also shared. All members of Committee unanimously decided that doctors as per enclosed list be empanelled.
- Performance of family planning activity during World Population Fortnight (27th June'19 to 24th July'19) was shared as under:-

NSV camp w.e.f. 11th to 24th July'19 and Tubectomy Camp w.e.f. 11th to 24th July'19 conducted at district hospital was shared. Total Five NSV cases and Twelve Tubectomy conducted at JPCH. Four IUCD Camps are conducted w.e.f. 11th to 24th July'19 at VSAS, MH Seelampur and MH Yamuna Vihar and PUHC Sonia Vihar 4.5 Pusta, Total 66 IUCD inserted in these Camps.

Total Performance of WPF including Camps.

- 1. Total No. of NSV Done: 07
- 2. Total No. of Tubectomy Done: 21
- 3. Total No. of IUCD: 232
- 4. Total No. of PPIUCD:-183
- 5. Total No. of PAIUCD:-22
- 6. Total No. of DMPA:-139

Discussed the implementation of various activities during "POSHAN Maah" (Pradhan Mantri Overarching Scheme for Holistic Nourishment) to be held in month Sep'19. Various activities to be undertaking under POSHAN Maah:-

For Anemia Test Treat and Talk (T3) Camp: - 30 such camps are planned for district in Govt. /Govt. Aided Schools. 500 beneficiaries (adolescents) to be screened through each camp, three teams per camp is to be made including ANM and LT.

For Defeat Diarrhoea (D2) Camp: - 30 such camps are planned in facilities and public places. Counseling for prevention of Diarrhoea is to be done.

Immunization:- Strengthening and monitoring to be done focus on underserved or unserved High Risk Area (HRA).

Urban Health Nutrition Day (UHND):- UHND sessions already planned for the month of Sep'19 in all facilities and quality to be ensured.

Home Visits: - identification of Low Birth Weight and Malnourished baby and proper referral by ASHA to be ensured.

All members appreciated the efforts and looking forward for great success of the campaign.

- ▶ Dr. Monika Bairathi, Incharge FP deliberated that if sterilization procedure is done by doctor where empanelment is in process or due, in such circumstances whether failure/ complication occurs than will be eligible for Family planning Indemnity Scheme (FPIS). Members took note of this and unanimously recommended that such failure or complication can be eligible for FPIS. Provided necessary required documents for empanelment are either available or provided by respective facility for empanelment of empanelment are either available or provided by respective facility for empanelment procedure under doctors (in case) which may be post-facto approval for empanelment procedure under FPIS.
