At the outset, DPO (RCH), welcomed the members. After brief round of introduction, meeting started and the proceedings of meeting are as follows:

Agenda NO. 1:- Two Failure cases of Sterilization :-

Case No. (I) -Munga Devi W/o Rajesh Kumar :-, Munga Devi W/o Rajesh Kumar R/o HNo—D-273, Gali No-4, Near Samuday Bhawan, Mandawali Vihar Harjan Basti, Saboli. Contact no-(7834830422).

Initial Procedure—MTP followed by lap ligation under I/V sedation. Both tubes ligated using fallope's rings in GTBH by empanelled surgeon Dr. Deepali Garg on 18.5.2012.

She filed for claim under FPIS on 22-4-2019 after detection of her pregnancy on 4.4.2019.

Repeat Procedure:- MTP followed by MiniLap Ligation by modified pomeroys method on 10.04.2019. Her cause of failure after discussion was found to be natural recanalization.

Case No (II) –Jyoti W/o Pawan :- Jyoti W/oPawan, R/o H NO-N/12B/157 huts, Kabir Nagar, Rana Pratap Bagh, Malka Ganj. Contact no-(9560574795)

Initial Procedure – MTP with lap ligation in SDN Hospital by Empanelled Surgeon Dr. Pooja Jain on 25.9.2018.

- She filed for claim on 02.05.2019 in SDN after detection of her pregnancy on 25.09.2018.

Repeat procedure :- MTP with Minilap Ligation 26-9-2018. B/L tube indentified, both fallope's rings were in place but one ring was occluding right tube partially. Both tubes ligated by pomeroys method, complete haemostasis achieved.

Her cause of failure after discussion was found to be technique error.

All necessary documents are available and all committee members unanimously decided to recommend the case to SISC for necessary compensation as per prevailing rules and regulation in this regard.

- Dr. Monica Ms (MCH) DHAS hospital pointed out that beneficiaries are not going for permanent method i.e tubectomy , there is decreasing number seen in DHAS.
- Dr. Kusha Puri & Dr. Monica brought to the notice of members that many clients who get IUCD inserted during post partum period want to get it removed and they are getting many requests for this. Removal is also difficult in some cases.
