Minutes of Meeting

Executive/Empowered Committee of State Health Society (Delhi) was held on 09/07/2019 at 4 PM in Conference Hall of Principal Secretary, Health & Family Welfare, GNCTD, Delhi Secretariat under the Chairmanship of Chairman, State Health Society (Delhi).

List of participants is as per Annexure-I.

Following issues were discussed.

Agenda Point No. 1: Appointment of Statutory Auditor 2018-19.

As per the guidelines under National Health Mission tender for Statutory Auditor for 2018-19 has been done. The process was delayed due to Model Code of Conduct (MCC) being in place till 24/05/2019. An open tender was called. Four firms quoted the same cost.

M/s Amit Ray & Co. has been identified as the successful bidder as per tender condition for a cost of Rs.1,18,000/- (inclusive of all taxes). An offer letter has been sent to the auditor.

Executive Committee of SHS (D) approved the selection of Statutory Auditor for the F.Y. 2018-19.

Agenda Point No. 2: Appointment of Concurrent Audit for 2019-20.

Executive Committee was informed that State Program Management Unit has done a combined tender for the appointment of Concurrent Auditor for 2019-20 for the State Health Society (Delhi) and 11 Integrated District Health Societies. The last date of submission of bid was 04/07/2019. The bids have been received and are being processed by the respective societies. The appointment has been delayed due to the Model Code of Conduct (MCC) being in place till last week of May-2019. Proportionate deduction will be done for the lapsed months.

Agenda Point No. 3: Financial Progress under National Health Mission.

Financial Progress for 2018-19 as per <u>Annexure-II</u>. was submitted to Executive Committee for appraisal.



Financial Progress for April & May-2019 as per <u>Annexure-III</u> was submitted to Executive Committee for appraisal.

Low expenditure against the approvals and fund availability was identified as a matter of concern. Chairman, State Health Society (Delhi) directed that Mission Director should review the financial progress every 15 days. All efforts should be made to expedite expenditure.

Agenda Point No. 4: Renewal for annual contract of contractual engagements of State Health Society (Delhi).

As per approvals received in the State Program Implementation Plan 2019-20, contract have been renewed of all the existing contractual engagements under Delhi State Health Mission except the Technical Officer & Statistical Officer under National Iodine Deficiency Disorder Control Program (NIDDCP) for which approval has not been accorded in administrative approval with the remarks "they may be deputed from existing regular cadre with the approval of Chairman State Health Society (Delhi) as per Annexure-IV & Annexure-V.

Executive Committee ratified the renewal of contract.

Agenda Point No. 5: Administrative approval of Delhi State Program Implementation Plan 2019-20.

Approval of the State Program Implementation Plan 2019-20 was received on 5th March-2019.

Following issues were submitted to Executive Committee of State Health Society (Delhi):

- Most of the ongoing activities as proposed by State have been approved except the
 post of Technical officer & Statistical Officer under NIDDCP. Executive Committee
 was informed that the State Program Officer has requested the Ministry for
 reconsideration of the proposal in the interest of the program.
- II. Executive Committee was informed that enhancement of monthly remuneration of contractual engagements under Delhi State Health Mission @ 5% for all existing human resource has been approved as a lump sum amount in the administrative approval of State Program Implementation Plan 2019-20 by Ministry of Health & Family Welfare.

Executive Committee approved enhancement at the rate of 5% of the consolidated remuneration drawn for 2018-19 for all existing human resource hired under Delhi State Health Mission, who have completed one year of service.

III. As per the approval of Governing Body of State Health Society (Delhi), experience bonus was proposed for all contractual engagements under National Health Mission As per the Administrative Approval of State Program Implementation Plan 2019-20,



it has been informed "Experience Bonus approved in principle, details provided in HR annexure doesn't match with the proposed amount. State may re-propose the same in supplementary PIP with details in required format".

Executive Committee approved that the amended proposal for experience bonus may be resubmitted in the Supplementary PIP-2019-20.

IV. Recruitment of Adolescent Health (AH) counselors

Nine (09) AH counselors have been approved as a part of ROP 2019-20. The posts were approved last year as well. However, the recruitment process couldn't be completed. The same is affecting adversely the functioning of Adolescent clinics as well as reporting of the activities carried out at the existing clinics.

It is to apprise that posts of AH counselors were not asked for particular districts. To ensure better supervision of the functioning of these counselors (in the absence of a dedicated District level Officer for Adolescent Health Program) and ensure optimum output, these counsellors may be posted by State at Adolescent clinics based on footfall during the last F.Y. as well as the level of facility wherein the clinic is established.

Executive Committee directed that the recruitment may be done district wise as per existing policy.

Agenda Point No. 6: Approval for revision in the human resource policy for hiring under Delhi State Health Mission.

Medical/Paramedical/Technical Managerial personnel are engaged on contract under Delhi State Health Mission by State Health Society & 11 Integrated District Health Societies

As per Human Resource Policy of National Health Systems Resource Centre (NHSRC), following conditions have been incorporated for hiring of consultants:

- 1. The probation period of a consultant will be of three (3) months beginning upon the commencement date of consultancy.
- II. During the period of probation, in case, if the consultant or the Organization is not satisfied with the work technique/performance, fifteen (15) days notice can be given on either side or payment in lieu thereof.
- During the probation period, the performance of the consultant will be assessed as to his/her ability to perform the job requirements to the required standards as specified in the key deliverables/TOR. In case, if the consultant fails to deliver as per the desired the expectation, the Division In charge must give adequate counseling to the consultant.



IV. In case of non-performance of the Consultant post counselling session may recommend discontinuation of the services of the consultant/advisor mentioning the reason for the same.

As per existing provisions, offer of appointment is given for particular financial year. To ensure that the personnel hired is able to provide envisaged benefits as per their skills, it is approved that the offer of appointment may include a period of assessment of 3 months with the following clause:

- There shall be an initial assessment period of three months from the date of first engagement.
- II. During the period of assessment, in case, if the Contractual Engagement or the Organization is not satisfied with the work technique/performance, fifteen (15) days notice can be given on either side or payment in lieu thereof.
- During the assessment period, the performance of the Contractual Engagement will be assessed as to his/her ability to perform the job requirements to the required standards as specified in the key deliverables/Terms of Reference. In case, if the Contractual Engagement fails to deliver as per the desired expectation, the Controlling Officer must give adequate counselling to the personnel with proper record.
- Iv. In case of non-performance of the Contractual Engagement post counselling session, Officer In charge may recommend discontinuation of the services of the personnel mentioning the reason for the same.

Executive Committee approved that the annual renewal of contract which is being done based on satisfactory performance appraisal of the contractual engagement may be done as per existing provisions.

Agenda Point No. 7: Release of pending dues of State Consultant, NTCP.

As per the information available, Mr. Prasanta Konar was appointed as State Consultant on contractual basis for National Tobacco Control Programme by Ministry of Health and Family Welfare in May 2010. The order regarding continuation of services of State Consultant was received yearly from the Ministry of Health and Family Welfare.

National Tobacco Control Programme (NTCP) was merged with DSHM for the first time in F.Y 2015-16 and the post of State Consultant was not approved in the administrative approval of State Program Implementation Plan and Supplementary PIP 2015-16 and he was asked to discontinue.

The services of the State Consultant were continued as ongoing by the SPO, NTCP from 1st April-2015 to 6th August -2015 for which his monthly remuneration has not been paid due to non-receipt of approvals in PIP 2015-16.

The approvals for the post had been received in the administrative approval of State PIP 2016-17 & 2017-18 (Budget Head M.3.4).

Since the contractual engagement was allowed to worked from 1st April 2015 to 6th August 2015, his pending dues may be cleared from the funds approved for the post in 2017-18.

This agenda was submitted to Executive Committee for approval in its meeting held on 01/06/2018. Executive Committee directed that the proposal may be submitted to Chairman, State Health Society (Delhi) on file.

The proposal was submitted on file in which it has been directed to submit the agenda in the State Health Society (Delhi) meeting.

Empowered Committee approved the release of pending dues from available budget with the directions that henceforth due care should be taken to allow only those personnel to work who have been approved in the administrative approval of State Program Implementation Plan.

Agenda Point No. 8: Rationalization of existing resources

Under the Delhi State Health Mission, State is being supported by various categories of human resource to ensure equitable availability. Some districts have been reporting a wide gap in the availability of ANM.

Executive Committee approved in principle approval to rationalize the available human resource with proper justification to ensure equitable district wise.

Agenda Point No. 9: Enhancement of monthly remuneration of Medical Officer & Specialist.

Executive Committee was informed that Cabinet Decision No. 2641 dated 25/09/2018 for enhancement of monthly remuneration of Medical Officer & Specialist has been further amended vide Cabinet Decision No. 2698 dated 08/03/2019.

As per the order dated issued by Joint Secretary (<u>Annexure-VI</u>), counsel of minister has approved the amendment of cabinet decision no. 2641 vide which the benefits shall be given w.e.f. 01/07/2017.

Agenda Point No. 10: Proposal for revalidation funds for ongoing activity.

As per the information submitted by various program divisions, fund for few activities need to be revalidated for expenditure in the current year as per the directions received from Ministry of Health & Family Welfare.

Executive Committee approved revalidation of unspent balances as per Annexure-VII.



Agenda Point No. 11: Proposal for reallocation of fund.

As per the frame for implementation of ROP 2019-20, any reallocation to be conducted to by the state is to approved of the executive committee and the Governing Body of the State Health Society subject to the following conditions:

- 4.1 Maximum budget available for states to reallocate fund is 10% of the total approved budget.
- 4.2 The maximum amount that can be reallocated/taken out from any of the budget heads (excluding group B) should not exceed 20% of budget approved under respective budget heads.
- 4.3 Upon reallocation of fund to any budget head (excluding Group A), state may increase the quantity of the approved activities; no changes can be made in the unit cost approved a unit cost of India. For instance, if 4 batches of training have been approved a unit cost of Rs.50,000/- per batch, states may increase the number of batches to be trained based on requirement. However, the training cost per batch should not exceed Rs.50,000/-
- The unit costs/rates approved for procurement etc. are estimations. The actual would be per the 'discovered price' arrived at through a transparent and open bidding process as per relevant and extent purchase rules.
- 4.5 States to intimate FMG, MoHFW regarding reallocation of fund on quarterly basis along with 'Financial Management Reports' in the following format:

Agenda Point No. 12: Roll Out of "UDAAN" Menstrual Hygiene Scheme

Executive Committee was informed that "UDAAN" Menstrual Hygiene Scheme has been rolled out in Delhi w.e.f. 3rd April, 2019. Under the Centrally Sponsored Scheme under



NHM, Non-school going adolescent girls are being provided a pack of six sanitary napkins per month at a subsidized cost of Rs. 6/- .

ASHA workers have been entrusted with sale/distribution of sanitary napkins through Anganwadi Centres. First Wednesday of every month has been identified as the day for distribution of these sanitary napkins (with Thursday as the reserve day). Nearly 45,000 non school going adolescent girls are availing this facility at present.

To educate adolescent girls about various aspects of menstrual hygiene management, nearly 3000 health education sessions are being conducted every month.

More than 150 Adolescent Health Days have also been conducted across Delhi in the last three months to increase awareness about Menstrual Hygiene and "UDAAN" scheme. Cabinet Note is under submission to make the scheme "Free of Cost" for beneficiaries. Concurrence to subsume of funds approved under NHM under the scheme has also been received from MoHFW, GoI.

Agenda Point No. 13: Innovation proposal by an NGO R. K. Mission Free TB Clinic as a Model DTC cum District

A proposal was received from Chest Clinic R. K. Mission for the functioning of this Clinic as a model DTC cum DRTB Centre with its own recruits to ensure continued innovation and greater accountability while delivering services in a cost effective manner. The Central TB Division, Govt. of India had endorsed such innovation as per the minutes of the meeting held on 17-10-2018. This proposal of Rs. 93.32 lacs was proposed in the PIP 2019-20 and amount of Rs. 69.28 lacs has been approved in ROP 2019-20.

Executive Committee directed to put up the proposal on file for consideration of Chairman, State Health Society (Delhi).

Agenda No. 14: Proposal for approval of agenda points pertaining to Aam Admi Mohalla Clinic by Executive Committee:

A. Empanelment of Staff through Written Examination

As per the Cabinet Decision Pharmacist, Mohalla Clinic Assistants (MCAs) and Multi Task Workers (MTWs) are to be empanelled through written examination by MAMC after approval of Pr. Secretary (H&FW).

Accordingly, written examination was conducted by MAMC for MCAs on 13-01-2019 where in 1076 applicants appeared for the exam out of 1421 applications received through online. Conduction of written exam of pharmacist and MTW though IP University with the approval of Chairman, State Health Society after refusal of MAMC (Pharmacist -2812 applications and MTW- 11165 application) received.



Total estimate received from IP University for conduction of exam for 13977 is Rs.4937500/-

100% advance to be given to IP University

Estimated expenditure to be paid Rs.12,36,965/- to MAMC for already hired vender for receiving of online applications (@Rs.75 plus 18% GST for each application)

Expenditure already incurred Rs.593736/-for condution of examination for empanelment of MCA given to MAMC and Education Department.

Fund proposed to be utilized from GIA-General out of Grant in Aid to DSHM for AAMC Project.

Executive Committee of State Health Society (Delhi) directed that the advance may be restricted to 40% of the total amount as per the provisions of GFR-2017.

B. MOU with WISH foundation. –LEHS/WISH has been engaged as technical and knowledge partner by GNCT of Delhi for providing software and hardware support for AAMC Pilot Project and in this regard, first MOU was signed with WISH foundation in year 2016 for six months only which was duly approved by Secretary H&FW and Hon'ble Minister of Health, GNCTD in line with Cabinet Decision-2309. LEHS/WISH is also working with other state govt. like Govt of Rajasthan, where WISH is providing support for their urban health program.

Further, the services of WISH foundation were extended as and when cabinet approved extension of project (vide cabinet decision no. 2423 and 2531). As per Cabinet Decision No- 2629 dated 28/08/2019 the AAMC pilot has been subsumed in AAMC project. The AAMC project is already running on the software provided free of cost by the WISH foundation.

At present 200 AAMC are functional out of which only 97 AAMC have IT application and rest of the AAMC are entering the data of patient in the OPD registers manually. To create transparency, it is necessary to provide TABLETS and Software in all functional AAMCs. It is further submitted that the tender for HIMS portal to capture OPD, investigations and other details of Patient for whole of the Delhi is under process and AAMC project is also included in the same software.

Thus, the MOU with WISH foundation may be signed till the HIMS portal is finalized.

Executive Committee directed that since the Memorandum of Understanding was not shared with the members in the agenda, the approval may be processed on file. Comments may be sought from the Department of Planning, Finance and Law.



Chairman, State Health Society (Delhi) may decide as per the provisions approved by the Cabinet.

C. Adoption of rate and services of M/s Unipath Diagnostics by State Health Society on the same terms and conditions of contract held with DGHS.

The engagement of Unipath Diagnostic from the period of 23rd September 2018 to 22nd September-2019 or till finalization of the tender of outsourcing of laboratory services to AAMCs whichever is earlier has been approved for AAMCs on the same terms and conditions of contract held with DGHS. Presently the number of total AAMCs is 190 but the number of AAMCs will vary as the project progresses and the Unipath Diagnostics shall have to provide the services to all functional AAMCs.

Bills may be paid from budget head "GIA to DSHM under AAMC Grant in Aid ."

Executive Committee ratified the approval.

- D. Empanelment of Doctors- Executive Committee was informed that at present doctors are being issued Offer of Empanelment on the basis of rank and preference of District. Executive Committee ratified the list of doctors empanelled in various districts is as per Annexure-VIII.
- E. Empanelment of Mohalla Clinic Assistants— Executive Committee was informed the 202 Mohalla Clinic Assistants (MCAs) have been given Offer of Empanelment as per the rank and their preference of districts as per details in Annexure-IX

Executive Committee ratified the list.

Subject: Amendment in cabinet decision no. 2641 dated 25.09.2018 regarding enhancement of remuneration of contractual engagements under Delhi State Health Mission.

The Council of Ministers considered the proposal of Hon'ble Minister (Health & Family Welfare) of amendment in cabinet decision no. 2641 dated 25.09.2018 regarding enhancement of remuneration of contractual engagements under Delhi State Health Mission and approved the following vide cabinet decision no. 2698 dated 08.03.2019:-

- (i) Medical Officers and Specialists will be given a 35% hike on the gross remuneration applicable as on 1st April 2017 (after adding the GoI enhancement for the year 2017-18). This 35% increase shall be inclusive of the 10% hike earlier allowed and already being funded by the State.
- (ii) The enhancement in remuneration shall be applicable with effect from 01.07.2017 in place of 01.04.2017.
- (iii) Upper limit of Conveyance allowances will be Rs.4,500/- per month on reimbursable basis as per guidelines of the State and shall be applicable prospectively.
- (iv) The net amount payable to the Medical Officer & Specialists from all sources (Gol & State Incentive) shall not be more than the amount paid to the contractual Medical Officer & Specialists of GNCTD on year to year basis.
- (v) Annual increment & loyalty bonus will be given every year as decided by Govt. of India.
- (vi) An institutional mechanism for a periodic review of the remuneration every three years shall be put in place where by the remuneration can be examined for performance / continuation or discontinuation of enhancements if so required. The next enhancement will be considered in year 2021.

The Mission Director, Delhi State Health Mission will further take necessary action in the matter as per provision and modalities approved in cabinet note and accordingly budgetary provision will also be made in respective annual budget.
