The meeting started with a welcome note by RCH Nodal Officer and a round of introduction.

### The agenda of the meeting was: -

- To Discuss Sterlization Faliure case of Sunita W/o Dilip Kumar (GGSG Hospital).
- To Discuss NSV Failure case of Amit Kumar S/o Pawan kumar (GGSG Hospital).

## Regarding Sterilization failure case of Sunita w/o Dilip Kumar :-

- Claimant underwent underwent original surgery on 23.04.2013 (MTP With Lap. Ligation) at GGSGH c reported to GGSGH on 02.02.2021 with U/S report of ? ectopic pregnancy in left fallopian tube dated 01.0 Exp. Laparotomy with left side salpingectomy and right sided tubectomy done on 02.02.2021.
- As per DQAC comments -As per per op finding there was left sided tubal rupture due to ectopic pregnancy. So salpingectomy done. Where as on right side ring was found to be in the place 1.5 cm away from Cornu. The tubal ends were close together. The tube was found to be short thus ends were ligated separately. So the cause of failure is spontaneous recanalization.
- The committee recommended the case for compensation under FPIS.

# Regarding Sterilization failure case of Amit Kumar S/o Pawan Kumar :-

- Claimant NSV was done on 10.02.2014 at GGSGH. He reported to GGSGH on 23.01.2021 with semen analysis . report of 15 million per ML semen count dated 25.01.2021 and USG report of his wife Mrs.Meena With SLF of 7 weeks 1 day  $\pm$  1 week pregnancy dated 27.01.2021 MTP done and injection MPA given on 31.01.2021.
- As per DQAC comments After scrutinization of the records, it has been found that the claimant had azospermia as . per records dated 15.05.2014. The semen analysis done on 25.01.2021 revealed sperm count 15 Million/ml and repeat sperm count dated 08.04.2021 shows 2-3 sperm /HPF. Thus it seems to be a case of spontaneous recanalization.
- The committee recommended the case for compensation under FPIS.
