Agenda of the meeting was as follows: -

1. A Case of ligation failure of Vitan shree W/O Bhannu Lal reported from RTRM Hospital.
2. Certification for PAIUCD & PPIUCD Empanelment requests received from RTRM Hospital.
3. Any other issue with permission of the chair.

Recommendation of the Committee:-

1. Discussion of a Sterilization Faliure case received from RTRM Hospital and claim for compensation in r/o Mrs. Vitan Shree W/o Mr. Bhannu Lal, R./o G-22/1, Jai Vihar, Ph -3, Baprola, Najafgarh, New Delhi-110043, was carried out in detail and the Chairman expressed his concern over the failure case.
2. The committee approved the claim and payment of compensation money to the client.
3. The fact that spontaneous recanalization may happen in sterilization cases, (GOI manual - Standards and Quality Assurance in Sterilization Services) was discussed. The concerned surgeon was empanelled in 2014 for minilap and lap ligation.
4. Regular quality checks to improve sterilization services with a view to reduce sterilization failure cases.
5. Follow up of this case is important, as resterilisation has been done on (21/01/2020). The option of hysterialphingographical checks for confirmation of successful operation is to be given to the client, and if she agrees, it should be provided to her for free. If the client does not desire to do so, denial is to be taken in writing from her.
6. Empanelment request received for PAIUCD, PPIUCD were reviewed by DQAC/DISC members and were recommended for empanelment. The RCH Nodal Officer was directed to prepare empanelment certificates and sent to RTRMH.

The meeting ended with a vote of thanks to the chair.
