
Integrated District Health Society, South West District requires accommodation for shifting of already running Seed Primary Urban Health Centers as mentioned below:-

at different places near the already running Seed PUHCs on rental basis. The building should have a carpet area of approximately 2000 square feet & have approx. 6-8 built up rooms & 2 toilets. Preference will be accorded to accommodation at ground floor within 1 KM radius of already existing Seed PUHCs with regular drinking water and electricity supply with separate meter and parking facility and wide road and proper ventilation.

The rent will be decided by the Rent Fixation Committee of PWD, GNCT of Delhi. Interested parties may send the proposal in sealed envelopes within 30 days of publication of this notice at the above mentioned address with the following details :-

1. Details of the building with full postal address.
2. Copy of blue print (map) of the approved plan of building.
3. Contact telephone number/s and address with landmark of the owner.
4. Copy of Aadhar card / Pan card / identity proof of the owner.
5. Declaration of the owner on the stamp paper of Rs 100/- that he/she will accept the rent which will be fixed by the PWD Govt of NCT of Delhi.
