The meeting started with a welcome note by RCH Nodal Officer and a round of introduction.

The agenda of the meeting was: -

2. To apprise DQAC members regarding empanelment of doctors for PPIUCD, PAIUCD and Sterilization services

Regarding Sterilization failure case of Pooja Singh w/o Santosh:- Pooja, female,27 years . She is G4P3L1D2. Pooja had undergone LSCS with B/L Tubal ligation on 6.3.2017 at DDUH. She reported on 4.9.2019 in DDUH with pregnancy UPT +ve on 4.9.2019. USG was done on 16.9.2019 and it shows Gsac of 17 weeks +3 days. Her PA examination on 4.9.2019 is suggestive of 18 to 20 weeks pregnancy and PV examination also correlates the same. She was advised for MTP with minilap but the claimant opted to continue the pregnancy.

The DQAC team reviewed the case and concluded that in view of poor case history with only one live child after 3 LSCS, and undertaking may be obtained from the couple regarding not undergoing any ART for conception for the present pregnancy. Further the case may be put on hold till this delivery happens in Feb '20 to ascertain the likely cause of failure.

Regarding Sterilization failure case of Ruby w/o Santosh Kumar:- Ruby, female, 29 years. She is P3L3A2. She had undergone MTP with Lap Ligation on 20.12.2018 at DDUH. She reported on 1.10.2019 in DDUH. Her UPT was positive, USG shows Gsac of 5 weeks 3 days and cardiac activity present on dated 1.10.2019. She was advised MTP with minilap and undergone the procedure of MTP with minilap on 21.10.2019 at DDUH.

The DQAC reviewed the case and the remarks of the DQAC are as follows.

As per perop. Findings on re sterilization (minilap), right sided tube fallop ring were not seen. Left sided ring was in place and thinned out tube. Reason for failure may? Slipping or breakage of ring? In proper application.

The DQAC recommended the case for compensation.

RCH Nodal apprised the DQAC members regarding empanelment of doctors for family planning services. The empanelment done is as follows:

Empanelment done for PPIUCD services: - SVBPH -9, DDUH- 10, GGSGH-10.

Empanelment done for PAIUCD services:- SVBPH -2, ESI -1, GGSGH -5

Empanelment done for sterilization services (Minilap) :- ESI - 1, DDUH -4, GGSGH- 2
