The State Health Society (Delhi) invites Proposals from firms of Chartered Accountants registered with ICAI / empanelled with C&AG and which meet all the minimum conditions as per the eligibility criteria given in Request for Proposal (RFP), for carrying out Monthly Concurrent Audit of all programs (including NDCPs & NCD) for State Health Society and eleven Integrated District Health Societies.



Request for Proposal (RFP)

For Appointment of Monthly Concurrent Auditor for State Health Society (SHS) and IDHSs of all programmes under NHM including NDCPs, NCD and State Specific Schemes i.e. Aam Aadmi Mohalla Clinic (AAMC), etc.



REQUEST FOR PROPOSAL (RFP) -

State Health Society, Delhi seeks to invite Proposals from Firms of chartered Accountants registered with ICAI as on 01.01.2024 (CAG empanelled Chartered Accountants firms) meeting the minimum eligibility criteria for providing their services for Monthly Concurrent Audit of State Health Society & eleven Intergrated District Health Societies (IDHS's) for Financial year 2024-25.

The details about the background of the auditee, the units to be covered in the audit, scope of work, terms of reference, and the eligibility criteria for selection of the C. A. firms are given in the following paragraphs.

Terms of Reference (ToR)

National Rural Health Mission (NRHM) of the Ministry of Health & Family Welfare (MoHFW) was launched on 12th April, 2005 by the Government of India (GOI) to improve medical facilities in the country. From 2013-14 onwards the NRHM programme has been subsumed under the umbrella programme of National Health Mission. NHM is overarching NUHM and also includes Communicable and Non-Communicable Diseases (NCD) as well. The NHM seeks to provide accessible, affordable and quality health care to the population, especially the vulnerable sections.

- 2. One of the visions of the Mission is to increase public spending on health from 1.3% to 2-3% of GDP, with the improved arrangement for community financing and risk pooling. The NHM has provided an umbrella under which the existing Reproductive and Child Health Programme (RCH), various National Disease Control Programmes (NDCPs) and Non-Communicable Disease (NCDs) have been repositioned. National Urban Health Mission (NUHM) has also been added as Submission of National Health Mission.
- 3. At present the following Programmes/Schemes fall under the National Health Mission:
 - Till FY 2021-22, fund release under NHM was as under the following (5) pools/components:
 - 1. NRHM-RCH Flexible Pool
 - A. RCH Flexible Pool
 - B. Health System Strengthening under NRHM
 - 2. National Urban Health Mission-Flexible Pool
 - 3. Flexible Pool for Communicable Diseases
 - 4. Flexible Pool for Non-Communicable Diseases, injury & Trauma
 - 5. Infrastructure Maintenance
- With a view to provide more flexibility to States/UTs and improve financial utilization, Dept. of Expenditure w.e.f. FY 2022-23 has approved the merger of pools. The present arrangement of pools: -
 - 1. Flexible Pool for RCH & Health System Strengthening, National Health Programme and Urban Health Mission
 - 2. Infrastructure Maintenance
 - 3. Strengthening of National Programme Management Unit

State Specific Schemes i.e. AamAadmi Mohalla Clinic project (AAMC), Rogi Kalyan Samiti (RKS), State specific Incentive for ASHA and contractual engagements under DSHM etc are being also implanted by DSHM.

4. Institutional and Funding Arrangements:

For the implementation of the above programmes, MoHFW has required the creation of an Integrated Health Society at State and District levels (registered as a legal entity at the State and District under Societies Registration Act, 1860). Such integrated State Health Society (SHS) works in close coordination with the Directorate of Health & Family Welfare and District Health Societies (DHSs) work in coordination with the District Collector and District Chief Medical Officer (CMO). Program implementation is done through its District Chief Medical Officer's office, Facilities/units, Community Health Centres (CHCs), Primary Health Centres (PHCs), Sub-Centres (SCs), Rogi Kalyan Samities (RKS) and Village Health Sanitation & Nutrition Committees (VHSNC). Certain activities may be managed at the State level such as drug procurement, IEC, civil works, training using specialized entities such as SIHFW, IEC Bureau, PWD, the Directorate of Health and Municipal Corporations for the urban health components. In addition, funds are also released from SHS/ DHS to NGOs and private entities under public private participation (PPP) arrangements.

Funding & Accounting Arrangements:

Funds for the various programs are transferred from Pay & Accounts Office of MoHFW to the State Treasuries and then from Treasuries to the SHS functioning in the State. Government of India transfer funds in the form of Grants-in-Aid to State treasuries through RBI on the basis of respective State Programme Implementation Plans (SPIPs) and approved Annual Work Plans which are prepared on the basis of District Health Action Plans (DHAPs) of each of the districts in the State. Under the umbrella of the integrated SHS/DHS each program has separate bank account, separate books of accounts and other financial records as per the requirements of each program and also submit separate financial activity reports at varying frequencies to the respective monitoring units in MoHFW (GOI).

5. Financing by Development Partners/ Donors:

Some of the programs of NHM are also supported by development partners such as the Asian Development Bank (ADB), The Global Fund to Fight AIDS, Tuberculosis and Malaria (GFATM) /World Bank etc. for which credit agreements have been entered into by GOI with the respective development partners. Compliance with specific fiduciary requirements of the development partners will additionally need to be reported by the auditors. Copies of the legal agreements and other project documents will be provided to the auditors, if needed, by SHS/ concerned Programme Division in the State.

CONCURRENT AUDIT

Concurrent audit is a systematic examination of financial transactions on a regular basis to ensure accuracy, authenticity, compliance with procedures and guidelines. The emphasis under concurrent audit is not on test checking but on substantial checking of transactions. It is an ongoing appraisal of the financial health of an entity to determine whether the financial management arrangements (including Concurrent control mechanisms) are effectively working and identify areas of improvement to enhance efficiency.

Independent Chartered Accountant firms are needed to be appointed at State & District Level to undertake periodical audits and report on vital parameters which would depict the true picture of financial and accounting health of the program.

Objective

The key objectives of the concurrent Audit include:

- To ensure voucher/ evidence based payments to improve transparency
- To ensure accuracy and timeliness in maintenance of books of accounts

- To ensure timeliness and accuracy of periodical financial statements
- To ensure compliance with laid down systems, procedures and policies
- To regularly track, follow up and settle advances on a priority basis
- To assess & improve overall Concurrent control systems

Scope of Audit

The responsibilities of the concurrent auditors should include reporting on the adequacy of Concurrent controls, the accuracy and propriety of transactions, the extent to which assets are accounted for and safeguarded, and the level of compliance with financial norms and procedures of the operational guidelines. The concurrent audit should be carried out both at State as well as District level.

The scope of work of "State Concurrent Auditor" is as follows:

- Audit of the SHS accounts and expenditure incurred by SHS
- Verification of Quarterly FMRs with Books of Accounts
- Audit of Advances at the SHS level
- Audit of the Provisional Utilization Certificates sent to GoI
- Monitoring timely submission of the District concurrent audit reports
- Detailed analysis and compilation of the District concurrent audit reports
- Vetting of the State Action Taken Reports and providing observations thereon
- Follow-up & monitoring over the ATRs prepared by districts on the observations made in the audit
- Preparation of Quarterly Executive summary to be sent to GoI in the prescribed format
- Any other evaluation work, as desired by the State Audit Committee

The scope of work of "District Concurrent Auditor" is as follows:

- Review of the DHS Accounts and expenditure incurred by the DHS
- Audit of Financial Statements of DHS
- Certification of the Statement of Expenditure
- Review and analysis of the Age wise and Party wise Advances Report
- Comparison between financial and physical performance and analysis
- Visits to Health Facilities in a way to cover all Health Facilities in a year.
- Filling in the checklist provided
- Vetting of the district ATRs and providing observations thereon
- Any other evaluation work, as desired by the District Audit Committee

Frequency

• Concurrent Audit will be carried out on a "monthly basis" with atleast 6 Man-Days per month along with submission of certificate of audit visit duly signed by State Program Manager or State Accounts Manager at State Level, District Program Manager or District Accounts Manager at District Level & Medical officer In-Charge at Unit Level respectively and the same should be submitted with bills for payment as per Annexure attached. Proportionate reduction in the bill shall be done for man days in case of non compliance to the minimum. In case of repeated default for more than 3 months, strict action will be initiated along with forfeiture of performance security and termination of contract.

Coverage

• The State Concurrent Auditor should ensure coverage of all the Districts and the District Concurrent Auditor should ensure that all the Health Facilities are covered over the entire year.

Specific work of Peripheral units / Hospitals etc.

- Checking of transaction posted.
- Certify the Bills / Vouchers maintained by the respective units.

- Certification of the record maintained by the respective units like expenditure register and cash book prepared by the CMO incharges or identified persons on monthly basis.
- Certify the list of advances given to the peripheral units as on 31.03.2025 visa versa (Once in a year)

State Level/District level Auditors

- The tender for the appointment of State/District Level Auditors is being floated through the advertisement at the state level. EoI format as prescribed in the guidelines along with the Terms of Reference is as per Annexure "Format for Submission of Technical Bid (Form T-2).
- Interested firms asked to submit their bids directly to the State/concerned districts in two parts- Technical and Financial bids. Both the bids should be submitted in two separate sealed envelopes, which will be opened in meeting of the State/District Audit committee.
- The State/District Audit committee would first open the technical bids and evaluate them on the basis of the criteria as prescribed in the guidelines (copy enclosed). The audit committee should arrive at a base minimum figure/ threshold and CA firms scoring above the base minimum figure/ threshold should be deemed to have technically qualified to undertake the job.
- Financial bids of only technically qualified firms should be opened by the committee and audit should be awarded to the lowest bidder.
- If the lowest financial bidder does not agree to undertake the audit work within the prescribed audit fee or the audit committee deems it unfit for any reason (reasons to be recorded in writing), the job may be awarded to the next lowest financial bidder if the firm agrees to undertake the job. However, the work may only be awarded to a technically qualified bidder (the firms which are above the base minimum figure of the technical evaluation)
- The final appointment will be done only after obtaining the concurrence of State Audit Committee and Deputy Director (Finance)/ Mission Director.
- In case the meeting of SAC gets delayed due to some reason, post-concurrence shall be obtained in the next immediate meeting.
- Deputy Director (Finance) as member-secretary of SAC may coordinate to ensure that excessive delays are avoided and consolidated intimations are received from all the districts.

Remuneration

- The fee structure for the concurrent auditor should be decided keeping in mind overall scope and coverage of audit. The state may provide an 'indicative range" for audit fees, however actual fees for state as well as district level audits should be decided through competitive bidding process.
- The respective audit committees may take a view on the rationalization of fees before approving the same and can also make suitable modifications to limits for the audit fee taking into account factors such as, inflation.
- The fees shall be appropriately reduced as per the decided scope and coverage depending on the date of appointment of concurrent auditor.
- The decision on remuneration should be judicious and balanced.

Term of appointment of the Auditor

State Level

- At the State level, the concurrent auditor appointed once can be retained/ reappointed for a maximum of two financial years i.e. current year and next year.
- However, the contract awarded should be for one year at a time and should be renewed next year on the basis of review of auditor's performance.

District Level

- At the District level, the concurrent auditor appointed once can be retained/ reappointed for a maximum total term of two financial years i.e. current year and next year.
- However, the contract awarded should be for one year at a time and should be renewed next year on the basis of auditor's performance review.

Contents of Audit Report

Concurrent Audit Report of a "State Health Society" should contain the following financial statements and documents:

- Duly filled in Checklist provided in the guidelines as per attached format in appendix II-B
- Financial statements as prescribed
 - o Audited Trial Balance
 - o Audited Receipts & Payments A/c
 - o Income & Expenditure A/c
 - o Balance Sheet
 - o Audited SoE
 - o Bank Reconciliation Statement
 - List of outstanding advances
- Observations and Recommendations of Auditor particularly covering the following aspects:
 - o Deficiencies noticed in Concurrent control
 - o Suggestions to improve the Concurrent control
 - o Extent of non-compliance with Guidelines issued by GOI
- Action Taken by State Health Society on the previous audit observations, along with his observations on the same.

Concurrent Audit Report of a "District Health Society" should contain the following financial statements and documents:

- Duly filled in Checklist provided in the guidelines as per attached format in appendix II-A
- Financial statements as prescribed
 - o Audited Trial Balance
 - o Audited Receipts & Payments A/c
 - o Audited Income & Expenditure A/c
 - o Balance Sheet
 - o Audited Statement of Expenditure
 - o Bank Reconciliation Statement
 - List of advances
- Observations and Recommendations of the auditor (including observations on Health Facilities visited)
- Action Taken by District Health Society on the previous audit observations, along with his observations on the same.

Notes:

- 1. Soft copy of the district audit report needs to be submitted to Deputy Director (Finance) at the state level.
- 2. The Director (Finance) at the Centre may call for the concurrent audit report of any district/ state.
- 3. The reports at both the state and district level will include consolidated report of RCH, Additionalities under NRHM, Immunization and NDCPs. In addition, it should also include instances of misappropriation/unauthorised diversion of funds as noticed during the audit.

Quarterly Executive Summary

- The state is required to send a Quarterly Executive Summary to the Centre by compiling the observations from the State as well as District Concurrent Audits
- The executive summary should provide information on aspects like quality of FMRs, maintenance of books of accounts, advances, compliance with audit observations etc.
- It shall be signed by both the concurrent auditor and the Mission Director at state level and sent to the Mission Director, MOHFW

Few Important points – things to remember

- Audit Reports should be submitted on a monthly basis. Sometimes, states/ districts tend to submit audit reports together for few months (e.g. submission of 3 reports at the end of the quarter even if monthly audit is being carried out). This practice should be strongly discouraged.
- In case of districts/ Health Facilities visited during the audit, the audit report should contain a separate checklist for each unit covered and respective observations should also be included.
- The audit report should also cover qualitative issues emerging from the audit other than the financial statements.
- Checklists should be thoroughly filled and each as aspect should be adequately elaborated. Observations reported on accounting and Concurrent control issues should be properly detailed and substantiated.
- Financial statement of NDCPs should be included in the consolidated audit report and audited
- Compliance status on the observations made in the previous audits should be properly reported and an Action Taken Report should be sent to the audit committee.
- Soft copy of the consolidated executive summary & ATR (district and state) should be mailed by the Deputy Director (Finance) at the state level to Mission Director in the Ministry of Health & Family Welfare on quarterly basis.

In conducting the audit special attention should be paid to the following:

- a) An assessment of adequacy of the project financial systems, including financial controls. This should include aspects such as adequacy and effectiveness of accounting, financial and operational controls; level of compliance with established policies, plans and procedures; reliability of accounting systems, data and financial reports; methods of remedying weak controls; verification of assets and liabilities; a specific report on this aspect would be provided by the auditor annually as part of the management letter
- b) Funds have been spent in accordance with the condition laid down by the Department of Health & Family Welfare, Government of India/Delhi from time to time with due attention to economy and efficiency, and only for the purpose for which the financing was provided. Counterpart contribution from State Government, where required has been provided.
- c) Goods and services financed have been procured in accordance with the relevant procurement guidelines issued by the GoI. However, for various programmes, special attention must be paid to the requirements of the agreement between GoI and development partners (such as for RCH-II, NTEP, IDSP and NVBDCP). Such requirements are available within the State concerned Program Officers. For such externally funded programmes, auditor must satisfy that all expenditure, including procurement of goods and services have been carried out as per the procurement manual of the individual programmes and guidelines issued by the Programme Divisions of GoI and have all the necessary supporting documentation.
- d) Expenditures if any, ineligible for financing by the development partners (as documented in the Development Credit Agreement with IDA and equivalent agreement with DFID) are disclosed adequately in the financial statements.
- e) All necessary supporting documents, records and accounts have been kept in respect of the project.
- f) The auditors are requested to put up the outputs in the Appendix enclosed.
- g) General: The auditor should be given access to any information relevant for the purpose of conducting the audit. This will normally include (other than all financial and procurement records) the SPIPs, AWPs, MOU/LOU signed between MOHFW and the State/ SHS, instructions issued by MOHFW regarding scheme guidelines (e.g. JSY), administrative orders issued by the SHS/ DOHFW/ Directorate of Health including cost norms etc. Where programs are financed by Development

Partners copies of the legal agreement, project appraisal document should be made available to the auditors. State Health Society (SHS)/DHS reserves the right to accept or reject any application without giving any explanation and change the evaluation criteria as per its requirements in the interest of organization.

Eligibility Criteria for State Health Society/Integrated District Health Society (IDHS's): The firm must be

- (a) empanelled with C & AG / registered with ICAI and their Head offices/ Branch Offices should be preferably be located in Delhi;
- (b) have at least 1 fellow members of the ICAI;
- (c) have an average turnover of Rs.20 lacs p.a in the last three year;
- (d) Firm must have an experience of more than ten years.
- (e) <u>An EMD of Rs. 10,000/- only by Bank Gurantee payable to State Health Society/ respective integrated district health society, district name, Delhi</u>

The selected firm for SHS's would have to submit signed copy of report on monthly basis (within 15 days of end of month) to State Program Management Unit & Offices of respective Program Offices.

The selected firm for IDHS's would have to submit signed copy of report on monthly basis (within 15 days of end of month) to State Program Management Unit & Offices of respective IDHS's.

11. Guidelines for Submitting the Proposals:

- a) The original and all copies of the Technical Proposal shall be placed in a sealed envelope clearly marked "TECHNICAL PROPOSAL" Similarly, the original Financial Proposal shall be placed in a separate sealed envelope clearly marked "FINANCIAL PROPOSAL" followed by the name of the assignment, and with a warning "DO NOT OPEN WITH THE TECHNICAL PROPOSAL." The envelopes containing the Technical and Financial Proposals shall be placed into an outer envelope and sealed. This outer envelope shall bear the submission address, reference number and title of the Assignment, and be clearly marked "DO NOT OPEN, EXCEPT IN PRESENCE OF THE COMMITTEE FOR AUDIT". The Society shall not be responsible for misplacement, losing or premature opening if the outer envelope is not sealed and/or marked as stipulated. This circumstance may be case for Proposal rejection. If the Financial Proposal is not submitted in a separate sealed envelope duly marked as indicated above, this will constitute grounds for declaring the Proposal non-responsive.
- b) Separate Proposals for Monthly Concurrent Audit of SHS and IDHSs should be submitted to the office of State Program Management Unit and respective IDHS's as per the list of addresses attached at annexure 1 & 2.
- c) Firms have to score at least 65% Marks in technical evaluation. Financial bids of only those firms who meet given eligibility criteria and qualify technically i.e. scores at least 65% marks in technical evaluation will be opened. The lowest i.e L-1 Bidder in financial bids will be awarded the contract under two bid systems.
- d) Minimum Fees: -Minimum fee for quoting the tender is Rs. 12000/- + taxes (as applicable) per month for state health society (SHS) and Rs. 5400/- + taxes p.m. for integrated district health societies (IDHSs).
- e) If lowest rates of 2 or more firms are found same than L1 will be decided on the basis of highest mark obtained in the technical bid. If the marks obtained in technical bid are also same, then L1 will be decided on the basis of experience of those bidders for NHM Concurrent Audits.
- f) If the last date of bid submission is declared a Gazette holiday, then next working day will be last date.

g) Performance Security Deposit: The final selected CA firm shall have to submit Performance Security deposit (10% of the contract value) in the form of FDR/Bank Gurantee issued from scheduled nationalized bank favouring provided by SHS(D)/ IDHS valid for 12 months from the date of signing the agreement and will be refunded on completion of the contract successfully.
