RCH Nodal Officer, SWD then outlined the Agenda of the meeting.


The following points were discussed:-

1. In the MPA failure case of MCW Janakpuri, DDUH refused to do MTP of the client. The Chairperson directed the members to provide further details

of the case i.e. the patient's OPD registration so that clarification may be sought from DDUH.

2. In the absence of most of the committee members, the chairperson directed RCH Nodal Officer to call a separate meeting at the CDMO level for empanelment of the doctors in presence of all concerned committee members.
3. RCH Nodal Officer gave a brief on WPD activities undertaken in the district and requested the Chairperson for provision of posters of Family Planning in the Cinema halls of SWD in their LED Scrollers. The Chairperson asked RCH Nodal Officer to provide the softcopies of the Layouts of WPD IEC Material. So that the same can be screened and theatres.
4. In other issues related to NRC and Maternal Health, members inform that no NRC unit exists in South West District at present for treatment of SAM/MAM cases. Chairperson directed the RCH Nodal Officer to send a detailed proposal, for setting up of NRC and initiating Maternal Health referrals from PUHCs/Dispensaries in IGH Dwarka.


