MINUTES OF MEETING

The 1st District Indemnity Scheme Committee (DISC) meeting of F.Y 2019-20 was held on 11.09.2019 in the O/o DC west, Rajouri garden under the chairmanship of DC, WD. The meeting was attended by the following:-

The meeting started with a welcome note by RCH Nodal Officer and a round of introduction.

The agenda of the meeting was: -

1. To discuss two sterilization Failure Cases from different hospital.

2. To discuss empanelment of new doctors for different family planning services of different hospitals of west district.

Regarding Sterilization failure case of Hemlata w/o Mahender Meena:- The case was discussed in the last meeting 06.07.2019 under the chairmanship of ADM, west. The relevant MOM of the last meeting are as follows:- The case was reverted back to the district with the comment to seek clarification regarding time frame for filling the claim with respect to the current guidelines. As the claimant reported to Jag Pravesh Chandra Hospital at 10 weeks on 4.7.2018, Pandit Madan Mohan Malaviye Hospital on 2.11.2018 with 28 weeks pregnancy and DDU Hospital on 28.11.2018.

The case was discussed and DQAC members are of the view that the records of both the above said hospitals required from the claimant.

The case was re discussed after getting records from Jag Pravesh Chandra hospital and Pandit Madan Mohan Malviya Hospital. It had been observed that Mrs Hemlata first reported to JPCH on 4.7.2018 as a case of G3P2L1 as spontaneous conception after ligation failure. There she was advised USG for gestational age. The patient never reported back to the hospital. Instead she went to Pandit Madan Mohan Malviya Hospital on 2.11.2018 at 28 weeks. There she did not disclose regarding ligation. From there she was referred to Safdarjung Hospital i/v/o previous LSCS with severe anemia (Hb -5.5gm %) Instead patient went to DDUH on 28.11.2018 where she gave h/o ligation failure. DDUH submitted the case to the district on 14.1.2019. It is further stated that the district forwarded the claim to the state within 3 months.

Regarding Sterilization failure case of Pooja w/o Arvind:- Sterilization failure case was reported from SVBPH, Patel Nagar on dated: - 5.8.2019. The claimant is 39 years, female. She had undergone MTP with lap tubal occlusion on 28.8.2015. She reported as a case of sterilization failure on 13.6.2019. Her UPT was positive on 13.6.209, USG dated 13.6.2019 showed 6 weeks +2 days intrauterine pregnancy. After that MTP was done at LHMC on 18.6.2019 and injection Antara was administered at SVBPH on 24.7.2019.

The DISC team reviewed the case and concluded that the patient did not opt for re sterilization after failure. Hence the cause of failure cannot be ascertained. The case is recommended for compensation.

Regarding PPIUCD empanelment:- The DISC has received total 14 applications from DDUH. Details are as under:-

DDUH - 3 DNB, 5 SRs and 6 JRs (all the applications were recommended for empanelment except Dr Akanksha Bansal due to non availability of signature of family planning incharge on certificate, only stamp was there).

Regarding Sterilization empanelment:- Total 7 SRs(1 application from ESI and 6 applications from DDUH) were received.

All the applications received for sterilization empanelment is recommended.

The meeting ended with the vote of thanks.
