The committee was informed that-

- Earlier cases of sterilization failure have been cleared from the district in time bound manner.

At the outset following two sterilization failure cases reported from Safdarjung Hospital were discussed in the meeting:-

Case-I - Name of the client - Anita W/o Ram Vilas

Pregnancy History - G₄P₃A₀L₃

Name of the facility: Safdarjung Hospital

Status of accreditation: Accredited for sterilization services

Name of Doctor - Dr. Jahnavi Meena

Status of Empanelment – Empanelled for Minilap & LSCS sterilization since 28.10.2013

Date of procedure – 18th June 2016

Type of procedure - Emergency LSCS with bilateral tubal ligation Histopathology - Two tubal segments lumen identified in both tubes

Detection date - 01.01.2021 Claim date - 12.02.2021 Proof of failure (UPT) - 01.01.2021

Sterilization certificate - issued on 18.08.2020

Date of Repeat Procedure - 04.01.2021, MTP with Inj. MPA. Per operation findings shows uterus at 8 wks and HPE report shows on 08.01.2021, multiple grey white soft tissue piece together measuring 2.5 x 1.5 x 0.5 cm. Sections examined show features consistent with retained products of conception.

Case file of Anita was reviewed by Committee members and recommended for sterilization failure claim to be paid.

Pregnancy History - G₄P₃L₃A₀

Name of the facility: Safdarjung Hospital

Status of accreditation: Accredited for sterilization

Name of Doctor - Dr. Supriti Kumari

Status of Empanelment - Empanelled for Minilap & LSCS sterilization since 19.02.2016

Date of procedure – 11.12.2016

Type of procedure – LSCS with bilateral tubal ligation

Histopathology – Two segments of fallopian tubes, lumen seen

Detection date - 01.01.2021

Claim date - 24.07.2020

Proof of failure – 31.01.2020 (UPT)

- 01.02.2020 (USG)

Sterilization certificate – issued on 17.01.2019

Date of Repeat Procedure - 01.02.2020, emergency laprotomy for ruptured ectopic & right oophorectomy with bilateral salpingectomy at SJH. Per operation findings shows dense intra abdominal adhesion bilateral tubes. adhesion right side ruptured decrease tubal ectopic lumen seen.

Histopath Report:-

Container 1: Specimen of right sided ovary with right fallopian tube measuring 1.5 cm in length and 0.5 cm in diameter. On cut section lumen seen. Attached paratubal cyst identified. Ovary measures 3 x 2 x l cm. Attached cyst is identified and measures 4 cm in diameter. On cut, serous fluid is present. External surface is congested. No capsule present. Bruch identified. No solid area of capillary excrescences identified. Sections from fallopian tube show intraluminal haemorrhage with marked transmural congestion. However, no definite chorionic villi could be identified. Attached ovary shows a corpus luteal cyst.

Container 2: Received a left segment of fallopian tube which shows fimbrial end of the fallopian tube. On cut lumen seen.

Case file of Rajni Devi was reviewed by Committee members and recommended for sterilization failure claim to be

As per DQAC the cause of sterilization failure is spontaneous recanalization in both cases reported from Safdarjung Hospital.

DQAC Members concluded that - For further processing Annexure-7 (as report on failure following sterilization) was filled up and duly signed for both cases by all District Quality Assurance Committee members, present in the meeting.

Based on the investigation report the following recommendation was made by District Family Planning Indemnity Sub-committee (DFPISC) members -

- "Reported case of sterilization failure of Anita W/o Ram Vilas, compensation may be given as
- "Reported case of sterilization failure of Rajni Devi W/o Charan Singh, compensation may be given as Rs.60,000/- if approved."

Medical certificate (Part B of Claim Form) to be issued by CDMO for Anita and Rajni Devi for compensation U/s I(c) for an amount of Rs.60,000/- for each failure cases of sterilization may be referred to state QAC. DFW for further approval/sanction.

Meeting ended with vote of thanks.
