Minutes of meeting of District Quality Assurance Committee Meeting (DQAC)

The meeting of District Quality Assurance Committee was held on 24th February 2021 in the Conference hall of the O/o District Magistrate (New Delhi District), 12/1, Jamnagar House, Shahjahan Road, New Delhi – 110001, at 2:00 PM.

The agenda of the meeting were as follows:-

- A. To discuss two sterilization failure cases from Maternity and Gynae RK Puram:-
 - (a) Mrs. Meena w/o Mr. Bablu
 - (b) Mrs. Ruby Devi w/o Mr. Akhilesh
- B. Any other issue with permission of chairperson.

The meeting started with welcome address by Dr. Roshmi Borah (DNO RCH, NDD), followed by brief round of introduction of all the members of DQAC, New Delhi District. Dr. Jyoti Sachdeva, SPO, Family Planning, DFW also spared time from her busy schedule and joined the meeting.

The attendance of the members is enclosed.

The following points were discussed:-

- 1. Dr. Roshmi Borah (DNO, RCH) apprised DQAC about the empanelment of services provider done during 2020-21 which is as follows :-
 - a) 17 Empanelment done for sterilization
 - b) 19 Empanelment done for PAIUCD
 - c) 20 Empanelment done for PPIUCD

Agenda A:-Two Cases of Sterilization Failure :-

- (i) **First Case of Sterilization Failure:** - Mrs. Meena W/o Mr. Bablu had undergone sterilization operation on 08/02/2019 at Maternity & Gynae Hospital R K Puram. (MTP with B/L Laparoscopic Tubal Ligation). Her LMP was on July 2020 and she came to hospital on 15-10-2020 with suspected pregnancy & confirmed by USG shows on 25+4 weeks on 16-10-2020. Patient did not turn up at the health centre within 90 days from the occurrence of failure. But Chairperson and other committee members were of the view that the delay in the time can be cordoned off due to COVID-19 Pandemic. The committee members after going through the case sheets were of the opinion that reason of the sterilization failure may be slipping of the fallope ring because re-surgery was not done. The committee members recommended that Mrs. Meena is eligible for the release of compensation amount as per FPIS.
- (ii) **Second Case of Sterilization Failure:** - Mrs. Ruby Devi W/o Mr. Akhilesh had undergone sterilization operation on 19/3/2020 at Maternity & Gynae Hospital R K Puram (CUT removal with B/L Laparoscopic Tubal occlusion Her pregnancy test came positive on 02/02/2021 and she informed the health facility on 3/02/2021.

The committee members after going through the case sheets were of the opinion that reason of the sterilization failure may be slipping of the fallope ring because re-surgery was not done.
