Agenda of the meeting: -

1. **Initiation of Family Planning Services in IGH, Dwarka.**
2. **Escalation of family Planning Services in Health facilities.**
3. **Certification for PPIUCD, PAIUCD and Minilap ligation Empanelment request received from JR & SR of SDDMASC.**
4. **Any other issue with the permission of the chair.**

The meeting started with a welcome address by RCH Nodal Officer, Dr. Devalina Sikdar and she then outlined the **First Agenda** of the meeting that was **Initiation of Family Planning Services in IGH, Dwarka**, in this regard Nodal Officer of Gynaecology Services, IGH Dr. Hema Jain stated that IGH planned to start some of the family planning services such as interval IUCD services, OCP, Chhaya & MPA etc. For permanent family planning

procedures counselling can be done at IGH and clients can be referred to RTRMH and SDDMASC till full implementation of Family Planning in IGH. She then requested that some IUCD insertion sets for Interval IUCD services, may be provided to the hospital to which Dr. Hemlata, HOD Obs & Gynae, RTRM agreed to give two IUCD insertion sets to IGH from RTRMH and requested that a mail/request letter be sent by IGH to RTRM for the same.

- **RCH Nodal Officer, Dr. Devalina Sikdar outlined the 2nd agenda of meeting that was - Escalation of family Planning Services in Health facilities.**
- Dr. Hemlata & Dr. Nisha pointed out shortage of dedicated staff for counselling for family planning acceptance. They both requested that NHM ANMs may be posted for the purpose. SDDMASC already has dedicated nursing staff for Family Planning.
- Dr. Pushpinder, NHM Nodal & Dr. Devalina, both declined this request as there is already a shortage of ANMs for primary health facilities. Moreover, it was reiterated that family planning counselling is not the responsibility of RCH or NHM alone, it is to be done by all Doctors/nursing staff. Dr. Devalina also pointed out that recently nursing orderlies, ICTC counsellors and other staff were trained at the state level for Family Planning counselling and their services should now be utilized.
- MS RTRMH agreed to post one nursing officer for dedicated family planning counselling.
- Dr. Kamal Kishore, surgeon, RTRMH pointed out the constraints regarding availability of OT, for NSV services, once a week only.
- **RCH Nodal Officer, Dr. Devalina Sikdar outlined the 3rd agenda of meeting that was - Certification for PPIUCD, PAIUCD and Minilap ligation Empanelment request received from JR & SR of SDDMASC.**
- Committee members checked all the applications and documents submitted as per guidelines and anonymous approval was given to all the applicants.
- RCH Nodal Officer was directed to prepare empanelment certificates and send it to SDDMASC at the earliest.




