MINUTES OF MEETINGS



The proceeding of the meeting:

- The meeting started with the welcome note by DNO RCH followed by introduction of all the members of the committee.
- 2. The Agenda of the meeting was discussed
 - A. Discussion regarding SQAC/DQAC visit
 - B. WPD report
 - C. NSV Fortnight
- 3. The chairperson was apprised about the importance of DQAC and guidelines of DQAC were briefly explained by DNO RCH. The compensation scheme was explained to the chairperson and committee members. The total number of accredited hospital for sterilization services was presented to committee members.
- 4. The committee was informed about the sterilization failure in the year 2018-19 and 2019-20 and also about the amount which has been provided to the clients for sterilization failure. There was no sterilization failure in district south east in the year 2020-21 & 2021-22.
- The total FP visits in the district was presented. Detailed discussion of hospital visit was done.
- The visit report of Apollo hospital and ESI Okhla was discussed. The chairperson and committee members were informed about observation by the team and recommendation. Chairperson directed that visit report to be shared with committee members also.
- It was discussed that a compliance report will be sent by Apollo hospital within 10 working days and by ESI Okhla within a month after issue of minutes of meeting. A

- 8. A letter to be issued to all the empanelled hospital in district south east to display the compensation schemes of family planning in their OPD and waiting area.
- A letter to be sent to ESI Okhla to open a bank account in their hospital so that the incentive to the beneficiary of family planning services can be provided. Failure of which a DO letter to be sent to Director ESI Delhi.
- 10. WPD report was discussed in detail. Chairperson directed that for better understanding a comparative report of last 3 years to be prepared and submitted so that the progress of family planning in the district can be seen.
- 11. Chairperson also directed that private hospital to be approached to hold Family Planning Camps in coordination with district RCH team in under privileged areas like, Navjeevan camp, Bhumiheen Camp etc.
- 12. Data to be prepared regarding child birth rate in all the ASHA area in district SED so that area where the birth rate is more than average a intensified approach of family planning services to be done in these areas.
- 13. NSV report of year 2021-22 was discussed. The committee was informed regarding the total NSV's done in our district along with the incentive amount Rs 1100/- and Rs 200/which has been already provided to the beneficiaries and motivator.
- 14. The chairperson and committee members were informed regarding HDC & PTK scheme. It was discussed that the implementation of HDC & PTK scheme of last 3 years of Delhi to be prepared and presented to the chairperson and committee members so that the effort of field workers with regard to family planning services can be seen.
