INSTRUCTION TO BIDDERS

1. General Instructions:

- i) The Bidder should prepare and submit the bid as per instructions.
- ii) The price quoted by the firm shall exclude all taxes and duties. This shall be quoted in the format as per attached Appendix 'J' only".
- iii) The tenders (technical and financial) shall be submitted in online mode, only physical documents will not be entertained (except EMD).
- iv) Any conditional Bid shall not be accepted.

2. Earnest Money Deposit (EMD):

- i) The tender shall be accompanied by Earnest Money Deposit (EMD) as specified in the Notice inviting Tender (NIT) in the shape of Bank Guarantee/Demand-Draft/FDR from any Schedule Bank in favour of "Director Health Services" payable at Delhi. **The sealed envelope containing the EMD must be deposited to the DIRECTORATE GENERAL HEALTH SERVICES, (tender inviting authority) to reach it before the closing time of the bid submission and dropped in the tender box placed in the office of Directorate General Health Services, Karkardooma Delhi, before the date and time already mentioned earlier.** Any delay in submission of EMD shall not be condoned and the bid shall be rejected.
- ii) *It may be noted that no one is exempt from deposit of EMD. Tenders submitted without EMD shall be rejected.*
Bid securities of the unsuccessful bidders should be returned to them without any interest at the earliest after expiry of the final bid validity or award of the contract. The EMD of the successful bidder will be returned without any interest, after receipt of performance security as per the terms of contract.
- iii) EMD of a bidder may be forfeited without prejudice to other rights of the DIRECTORATE GENERAL HEALTH SERVICES, if the bidder withdraws or amends its tender or impairs or derogates from the tender in any respect within the period of validity of its tender or if it comes to notice that the information/documents furnished in its tender is incorrect, false, misleading or forged. 
3. Preparation of Tender:

The bids are invited through TWO BID SYSTEM online as follows:

a) Technical offer:

Technical offer must be submitted online at GeM/<https://govtprocurement.delhi.gov.in> as per the instructions on the portal. The Tenderer must be uploaded, following documents duly signed and stamped by the authorized signatory as per terms & conditions of the contract.

- ii) Scanned copy of EMD must be uploaded along with tender documents at the time of bid.
- iii) Registration details of the bidders like copy of the relevant deeds e.g. Proprietorship/Partnership Deed or incorporation details of the company and Letter of Authority as per Appendix-"C"
- iv) A declaration from the bidder in the format given in the "Appendix-I" to the effect that the firm has not been declared as defaulter/black-listed by any competent authority of a government department, government undertakings, local bodies, authorities at the time of submission of the bid.
- v) Copy of audited final accounts, profit and loss accounts, ITR along with all relevant appendices in support of turnover of the bidder from last three financial years i.e. 2021-22, 2022-23, 2023-24 must be uploaded. A CA certified certificate in respect of last three year turnover of bidder may be submitted for eligibility of the firm/ company
- vi) Scanned copy of PAN Card of Proprietor or the firm as the case may be.
- vii) Statement of Statutory Auditor stating test specific MoU of collaborating labs and test specific in house testing with External Quality Assurance (EQAS) And Internal Quality Assurances(IQAS). (Appendix "G") .
- viii) Bidder should have performed at least average 10 lakh test in last three financial years i.e 2021-22, 2022-23, 2023-24. A CA certified certificate for the same may be annexed/uploaded. Appendix -L.
- ix) Authority letter in respect of authorized signatory for signing of all documents in this tender must be annexed/uploaded.

b) Financial offer:


The financial proposal shall be submitted online at GeM/<https://govtprocurement.delhi.gov.in> as per instructions on the portal. Prices shall be exclusive of all taxes & duties and quoted in the Performa enclosed at Appendix "J" as per scope of work/service to be rendered.

4. Tender Validity Period:

- a) The tender shall be valid initially for **three years** (work done during the first year has been found to be satisfactory and performance security is renewed for second year).
- b) Acceptance and the prices quoted shall remain valid for the duration of the contract and the bid shall remain valid for a period of 240 days after the date of opening of technical bid.

5. Tender Submission:

The bids are invited through TWO BID SYSTEM online for technical and financial bid. The offer shall contain no interlineations or overwriting except as necessary to correct errors, in which cases such correction must be initiated by the person or persons signing the tender. In case of discrepancy in the quoted prices, the price written in words will be taken as valid.

6. Opening of Tenders

The technical bids will be opened online through the e-tender portal website GeM/<https://govtprocurement.delhi.gov.in> at the time & date specified in the schedule.

The bidders may attend the bid opening if they so desire

- i) Online bids (complete in all respect) received along with EMD (Physically) shall be opened in presence of bidders/ representative if available. **Bids received without EMD shall be rejected right away.**
- ii) **Financial bids of only those bidders, whose bids are found technically qualified by the Technical Evaluation Committee, shall be opened.**

7. Corrupt Or Fraudulent Practices, Blacklisting, Action Under Criminal Law:

The tender inviting authority requires that the Bidder under this bid observes the highest standards of ethics during the bidding process and contract performance. In pursuance of this policy, the terms are set forth as follows:

- i) "Corrupt Practice" means the offering, giving, receiving or soliciting of anything of value to influence the action of a public servant in the procurement process or in contract execution; and
- ii) "Fraudulent Practice" means misrepresentation of facts in order to influence the procurement process or execution of contract to the detriment of the Department/Govt. and includes collusive practice among Bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the Department/Government of the benefits of free and open competition;
- iii) The tender inviting authority shall reject a proposal for award or cancel the contract awarded if it determines that the bidder recommended for award has engaged in corrupt or fraudulent practices during or after the bidding process.

EVALUATION OF TENDERS

1. Scrutiny of Tenders:

The tenders will be scrutinized to determine whether they are complete and meet the essential and important requirements, conditions and whether the bidder is eligible and qualified as per criteria laid down in the Tender Enquiry Documents. The bids, which do not meet the afore said requirements, are liable to be treated as non-responsive and may be ignored. The decision of the DIRECTORATE GENERAL HEALTH SERVICES as to whether the bidder is eligible and qualified or not and whether the bid is responsive or not shall be final and binding on the bidders. Financial bids of only those bidders, who qualify the technical bid, will be considered.



2. Clarifications:

(i) To facilitate evaluation of Proposals, the DIRECTORATE GENERAL HEALTH SERVICES may, at the sole discretion, seek clarifications/ supplemental information from any Applicant regarding its proposal. - The Service Provider is required to provide laboratory diagnostics at existing Delhi Govt. Hospitals, Polyclinics, Delhi Govt. Dispensaries, Seed PUHCs and Aam Aadmi Mohalla Clinics (AAMCs) of Govt of Delhi . The number of health facilities can be increase or decrease during the period of contract.

2. In the case of Mobile Health Clinics/Camps, these Clinics/Camps will be organized @ one Clinic/Camp per week or more at a site according to need based assessment of the public. Tests which are advised at such clinics/camps will also be covered under the proposed outsourcing of Non- Radiological Laboratory Diagnostics. The venue and date of the Mobile Health Camp sites will be shared with the agency, when finalized by the Department. "The camp details will be given at least 5 working days prior to the camp through electronic mode of communication".
3. The Service Provider is also required to provide laboratory diagnostics for new units that may be established or increased/decreased as per the policy/requirement of department during the period of contract. The Service Provider shall be able to provide these services at newly established units within 2 weeks of the work order issued by DIRECTORATE GENERAL HEALTH SERVICES, as per same terms and conditions.
4. The Service Provider shall arrange for Pick Up and labeling of all samples of patients (Blood/Urine/Stool/other samples) once daily, from all health facilities during the working hours of the facility i.e 10:00 a.m to 04:00 p.m/ or as per requirement of the health facilities on all working days. (as notified by the Govt. time to time).
5. The Service Provider will also carry out Pick Up and labeling of all samples of Patients attending the Mobile Health Camps during the Camp timings.
6. The Service Provider will ensure the safe transport of the samples in proper containers as per due procedure, following the cold chain precautions and undertake testing at its labs.
7. All the operational cost within the declared scope of work including the cost of providing adequate quantities of lab consumables, vacutainers, needles and syringes, cotton, containers, swabs, gloves, barcode stickers, band aids and any other item or material required for sample collection or transportation from all health facilities of Govt. of Delhi will be borne by the Service Provider.
8. The Service Provider shall ensure delivery of the lab report electronically as well as in physical form to the designated doctor in-charge of the facilities, duly signed by the reporting specialist as per TAT.
9. The test reports of samples tested in health facilities will be delivered electronically to the health facilities for further transmission to the Camp attendees. The test reports should also be available to individual patients through Internet access.
10. Critical tests reports shall be communicated to the concerned facility in-charge.
11. Tests tagged as QNS shall be repeated by the service provider without any additional charges.
12. **The all the three successful bidders shall have to provide a common customized Lab Information Systems (LIS) as per requirement of the department which is completely based on mobile OTP authenticated from patient. LABORATORY INFORMATION SYSTEM (LIS) :** LIS should have feasibility to integrate with the any government portal of the department as per requirement time to time.
- 12.1 The service provider should set up a Laboratory Information System covering all the processes of laboratory services (including but not limited to pre-analytical, analytical and post analytical). The LIS should be capable of providing data for all the key processes online on real time basis. Necessary software and hardware infrastructure (if and when required, on mutual consent of both parties) shall be put in place in each healthcare facility on or before commencement of services. The coverage and functionality of LIS should be as per good industry practices. In case the HMIS

of the health care facility is available, the same will be integrated by the service provider with their LIS. A dashboard (performance measurement and reporting) should be created. The LIS and dashboard should be made available to the designated Nodal Officers, all members of expert committee and the oversight board and to any other officer as and when required by the Authority. The service provider will provide a user ID and password for this purpose to each of these officers to access LIS on online basis to generate and obtain necessary information, data or report on lab services with a view to review and monitor compliance of the service provider as per this agreement.

12.2 A system of online registration of patients from day one and aadhaar based biometric tracking of patients shall be setup within 3 months of commencement of work.

12.3 The LIS will also have the following data, as mentioned at A&B below as per requirement of Authority work out in manual consultation and the same should be accessible to officers authorized by the Authority. Further, the Service Provider will provide a printed report of the same (A&B) which will be duly verified by the designated Nodal Officer of the health care facility.

12.4 The Service Provider should keep a record on LIS of notifiable Infectious Diseases and Communicable diseases. The information of the same is to be sent to IDSP portal and IHIP portal and to the concerned designated Nodal Officer of the Delhi Government health facility within 12 hours of report generation and to keep a record of the same on prescribed formats. Service provider will also enable active and passive surveillance of priority pathogens as defined by NCDC.

12.6 The lab shall electronically maintain equipments calibration as well as periodic maintenance data and the same should be available on LIS

12.7 The confidentiality of medical records should be maintained and adequate arrangements should be made for cyber security.

12.8 To ensure compliance to the national program guidelines the service provider will sent (a) all malaria positive peripheral blood smears and (b) 5% randomly selected malaria negative peripheral blood smears to state cross checking lab (parasitology lab Room No. 1 First floor pathology block MAMC Delhi).

b) Hard copy should be available by next working day or as per TAT at the Delhi Government health facility for collection by the patient/authorized person. The report will also be available on LIS to the designated nodal officer of the healthcare facility. A link of the report should reach the patient's and treating doctor's/designated nodal officer mobile via SMS.

c) In case of histopathology/cytology reports, stained slides, blocks and microscopic images shall be provided, whenever required, free of cost.

14. CRITICAL VALUE REPORTING

Critical value reports requiring urgent attention shall be addressed as per protocol of urgent reporting and record for the same shall be appropriately maintained in LIS. Critical tests reports shall be communicated to the concerned designated Nodal Officer or treating doctor on the same day or at the earliest via SMS. 15. RE-EVALUATION OF SAMPLES

The Service Provider must preserve all the samples for a minimum period as per NABL norms. Further, copy of SOP of preservation of samples as per NABL norms will have to be submitted at the time of signing of MOU so that in case of any discrepancy designated Nodal Officer/Treating doctor may get sample re-evaluated and the cost of the same will be borne by the Service Provider. The Authority shall not pay the service provider for any repeat testing required by the designated nodal officer/treating doctor, on account of deficiency in the earlier test. 16. COMPLAINT POLICY

16.7 The Service Provider shall undertake the required corrective and preventive actions to ensure that the concerned complaint / issue are not repeated.

16.8 Service provider will provide a summary of all complaints received and the remedial action taken to the designated nodal officer along with reasons for any delay in attending to the complaint / pending complaints. This report will contain the complaint with the ticket number and the action taken.

16.9 The Service Provider should do a root cause analysis of all the complaints received and should submit the same to the designated nodal officer

17. MONITORING AND SUPERVISION

Online monitoring and supervision will be done on daily basis by designated nodal officers and by expert committee on quarterly basis. The service provider will provide the user ID to all the designated officers, members of expert committee and members of Oversight Board and any other officers authorized by the Authority, for accessing the LIS for quality, billing, patient reports etc. The user rights for each level will be granted commensurate to the roles assigned in this tender.

- (h) Root cause analysis report of complaints received.
- (i) Check NABL certification and any other records within the scope of this tender as desired by the Committee.
- (j) Meeting of expert committee will be conducted on quarterly basis and minutes for the same along with action (Corrective and Preventive action as well as penalty if any) taken to be submitted to Oversight Board.




- (i) The Service Provider shall at all times comply with applicable laws and regulations pertaining to the providing outsourced (Non-radiological) laboratory services in the area where the services are being provided.
- (ii) The service provider shall comply with all statutory provisions including provisions regarding medical education qualifications, eligibility criteria, human resources for lab services, Bio- Medical Waste Management, Bio-Safety Occupational and Environmental Safety etc. which shall be responsibility of service provider.
- (iii) Compliance of Bio-Medical Waste (Management and Handling) Rules 2016 and amendments there of and regulations including Clinical Establishment Act 2010 and all other applicable Labor Laws, Rules and Regulations amended from time to time shall be responsibility of service provider.
- (iv) Legal liability to the extent of reporting of tests and its results/reports for each reported case extends to the service provider solely.
- (v) The service provider shall, at all times, indemnify and keep indemnified the Authority against any claims in respect of any damages or compensation payable in consequences of any accidents or injury sustained or suffered by its employees or agents or by any other third party (patients tested included) resulting from or by any action, omission or operation (including services as envisaged in this RFP) conducted by or on behalf of the service provider/its associate/affiliate etc. All claims regarding indemnity shall survive the termination and expiry of the contract.

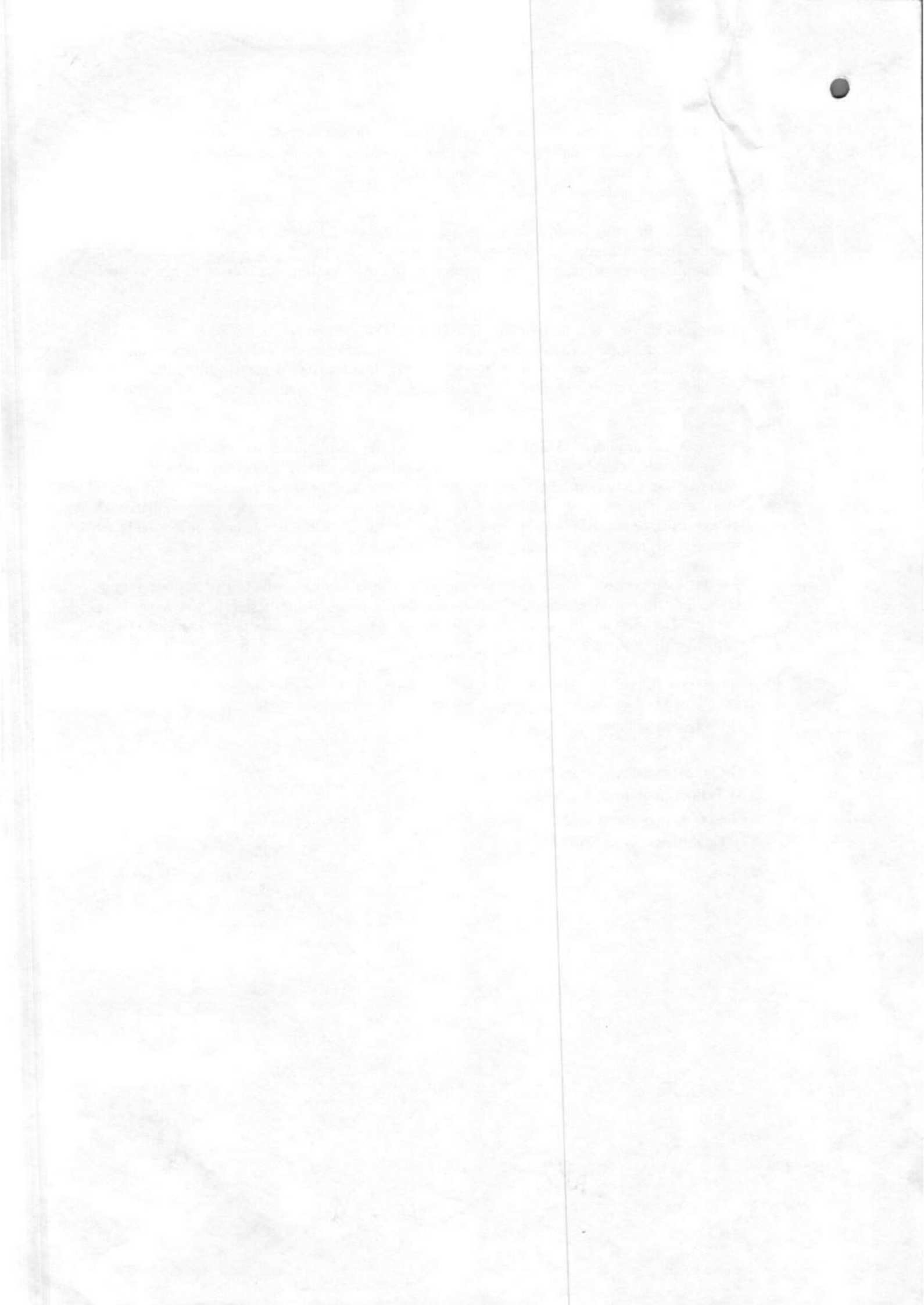







SECTION-V

ELIGIBILITY CRITERIA

1. NABL accredited laboratories in India may participate in the tender provided that, the bidder has one or more laboratory in Delhi NCR for conducting laboratory tests. The laboratory should have at least 100 tests listed in DGHS rate lists under the scope of NABL. (NABL accreditation certification and scope of test is required). Selected lab will increase the scope of NABL accreditation test limits till 70% of total tests within 1 year of award of work / signing of agreement. An undertaking in this regard is required on Rs. 100/- stamp paper duly signed and stamped by the authorized signatory.
2. The Bidder shall be a sole proprietor/partnership firm/company with registration under relevant law of the land. **No consortium/joint venture for the purpose of qualification of this tender is permitted (registration certificate regarding proprietor ship/partnership/company is required).**
3. The Bidder shall have at least three years' experience in medical laboratory services in public/private sector. In support of this Bidder have to submit Audited Financial Statement including Profit and Loss Accounts including relevant appendix and ITR that shall have minimum average turnover 30% of the estimated total cost of the tender based on last three financial years 2021-22, 2022-23 and 2023-24.
4. The Bidder is not blacklisted by any authority at the time of submission of bid.

TERMS AND CONDITIONS

1. Signing of Contract:

The DIRECTORATE GENERAL HEALTH SERVICES shall issue the Notice for Award of Contract to the successful bidder through e-mail/hard copy which shall also be placed on the website GeM/<https://govtprocurement.delhi.gov.in> within the bid validity period. The successful bidder will be required to execute a formal agreement unconditionally within 15 days of receipt of such communication on non-judicial stamp paper of Rs. 100/- and the cost shall be borne by the bidder.

2. Lock in period of Contract:

Selected vendor will not quit/leave the services within two years from the commencement of services if vendor quit/leave the services before two years PG will be forfeited and vendor will be blacklisted for three years by the competent authority.

3. Modification to Contract:

The contract when executed by the parties shall constitute the entire contract between the parties in connection with the jobs/services and shall be binding upon the parties.

The contract shall be valid for a period of three years from the date of approval by the Competent Authority. The tender may be extended for two more years with satisfactory performance and mutual consent.

4. Performance Security:

a) The successful Bidder shall be required to furnish Performance Security from any Scheduled Commercial bank in the form of Bank Guarantee as per format in Appendix-K




- i) If dispute or difference of any kind shall arise between the Health Department and the Service Provider in connection with or relating to the contract, the parties shall make every effort to resolve the same amicably by mutual consultations.
- ii) If the parties fail to resolve their dispute or difference by such mutual consultations within thirty days of commencement of consultations, then either the Health Department or the Service Provider may give notice to the other party of its intention to commence arbitration, as hereinafter provided. The applicable arbitration procedure will be as per the Arbitration and Conciliation Act, 1996 of India. In that event, the dispute or difference shall be referred to the sole arbitration of an officer to be appointed by the Secretary, H&FW, GNCTD as Arbitrator. If the arbitrator to whom the matter is initially referred is transferred or vacates his office or is unable to act for any reason, he/she shall be replaced by another person appointed by Secretary, H&FW, GNCTD as Arbitrator. Such person shall be entitled to proceed with the matter from the stage at which it was left by his predecessor.
