In the said meeting following points discussed and also recommended by the committee:-

- 1. It has been observed that failure cases are being reported within 1 year of sterilization which raises questions over quality in the programme. Hence committee is of the view that all the cases done by newly empanelled doctors must be supervised by experienced service providers.
- 2. A long acting contraceptive method/sterilization must be offered to all failure cases ager abortion if the beneficiary not willing to continue the pregnancy.
- 3. All the failure cases must be discussed by Facility Quality Assurance Committee and minutes shared with the District regularly for ready reference during DQACs.
- **4.** All three cases have been declared as fit for compensation according District Indemnity Sub Committee and to be forwarded to SISC for further action.

The meeting ended with the vote of thanks to the chair.
