MINUTES OF MEETING

With the permission of competent authority (District Magistrate, West) the 1st District Indemnity Sub Committee (DISC) meeting of F.Y 2020-21 was held on 12.06.2020 in the Conference Hall of GGSGH, Raghurib Nagar under the chairmanship of CDMO, West District. The meeting was attended by the following:-

1. Dr Sunita Prasad	CDMO, WD
2. Dr. M Mani (Gynecologist)	Member, DISC (GGSGH)
3. Dr Rajesh Bilala (Anesthetist)	Member, DISC (GGSGH)
4. Dr Beena Aggarwal (Surgeon)	Member, DISC (GGSGH)

The meeting started with a welcome note by RCH Nodal Officer and a round of introduction.

The agenda of the meeting was: -

1. To comment upon pending case of Puja Singh w/o Santosh Singh for the month of October 2019 after delivery.
2. To discuss two sterilization Failure Cases from 1 case from DDUH hospital and another from GGSGH, Raghurib Nagar.

AGENDA 1 :-

Regarding Sterilization failure case of Puja Singh w/o Santosh Singh (Oct 2019):-

- Claimant underwent emergency Caesarean section on 22.1.2020.
- Per operative findings:- tubes and ovaries could not be visualized due to dense adhesions between uterus and abdominal wall , hence definite cause of the failure cannot be ascertained.
- As per mail received from DDU hospital, the couple denied any history of having undergone any ART procedure.
- The DISC also took note of the discrepancy in spelling of Name of claimant in hospital and personal records and satisfies itself that Puja and Pooja are same person. DISC advised that advisory to hospital be sent to be careful while documenting names in case sheets and certificate.

The DISC recommended the case for compensation.

AGENDA 2 :-

Regarding Sterilization failure case of Simran Kaur w/o Vijay:- Simran Kaur , female 30 year old (G3P2L2) undergone laparoscopic ligation on 22.7.2014 at GGSG Hospital, Raghurib Nagar. She reported on 28.11.2019 in GGSG Hospital with pregnancy (UPT +ve on 27.11.2019 and USG on 27.11.2019 with IUG Sac approx 5 weeks 3 days and cardiac activity present). She was advised MTP with repeat sterilization and underwent the procedure of MTP with minilap on 6.12.2019.

The DISC reviewed the case and the remarks of DISC are as follows:-

As per, per operative findings the right ring properly placed , left ring found 1 cm from cornua partially occluding the tube , hence reason for failure may be partial slippage of fallop ring on left sided fallopian tube.

The DISC recommended the case for compensation.

Regarding Sterilization failure case of Poonam w/o Balram :- Poonam 31 year old, female (G6P3L3) had undergone Laparoscopic tubal ligation on 20.11.2018 at DDU Hospital, Hari Nagar. She reported on 14.2.2020 in DDU Hospital with pregnancy (UPT +ve on 14.2.2020 and USG done on 18.2.2020 with the finding "ET 11 mm no IUG Sac, left adenaxa shows SOL 26x16mm right ovary normal mild peri fluid in pelvis and surrounding the adenaxal region". She was advised for Exploratory Laprotomy with right sided Salpingectomy for ectopic, but Exploratory Laprotomy with Bilateral salpingectomy done on 21.2.20 (because on left side ligation could not be possible).


The DISC reviewed the case and the remarks of DISC are as follows:-

As per operative findings and notes left sided fallop ring seen and tubal segments completely separate from each other by 1 cm distance. Right sided fallop ring seen and Tubal ectopic pregnancy seen lateral to the ring. Likely cause inherent.

The DISC recommended the case for compensation.

Both cases were recommended after confirming / discussing / reviewing presence of essential documents and fulfillment of other mandate example HMIs reporting, quality circle review, failure trend of surgeon concerned etc.
