Minutes of DISC Meeting

A Meeting of District Indemnity Sub Committee (SHAHDARA DISTRICT) was held under the Chairmanship of the District Magistrate on 24.06,2021, 3:00 PM at the Conference Room, E-Block, D.C. Office Complex, Nand Nagri Delhi-93, to discuss the set agenda.

The meeting was attended by following members:-

The proceedings of meeting are as follows:

Agenda No. 1:- 02 Cases of Sterilization Failure, 01 each from SDN Hospital and GTB Hospital:-

- 1. Case of Mrs. Anita w/o Mr. Sagar: R/o H.No. S-3, Gali No. 1, Bhopura, DLF, Gaziabad, U.P. Contact No- 9654596022.
 - Initial procedure:- MTP with B/L Lap. Ligation performed at SDN Hospital by the empaneled surgeon Dr Pooja Jain on 29.11.2019 under short GA, B/L Fallopian tubes wereidentified and Fallope rings inserted.
 - The client reported to the OPD on 14.01.2021 with UPT positive and Sterilization Failure has been confirmed by USG on the same day.
 - Repeat Procedure:-MTP was done by Medical Methods on 14.01.2021 followed by Inj. Antara and was advised for follow-up at every 3 months.

The DISC Members discussed the case in details and it has been found that some relevant & valid documents are further required to clear the claim.

Therefore, all the members of DISC have unanimously suggested that in this case further discussions may be held in the next meeting of the Committee in the presence of the Concerned Nodal officer from the Hospital with all the relevant documents with her in original.

- Case of Mrs. Rekha w/o Mr. Rajender Kumar: R/o C/470, Gokalpuri, Delhi. Contact No. 9871032114.
 - Initial procedure:- MTP by suction evacuation F/B Minllap Ligation by modification of Methodperformed at GTB Hospital by the empaneled surgeon Dr. Geetanjali (SR) on 16.04.2014 under GA. Per-operative findings being Right side Fallope Ring present in Broad ligament and Left side tube ligated with Fallope Ring. (This was the repeat procedure following failure of Lap ligation on 16.09.2013, for which the client had been compensated as per FPIS Rules processed on 17.04.2014.)
 - HPE findings having two Segments of fallopian tubes (on dated 22.04.2014).
 - The client reported to the OPD at SDN Hospital on 24.12.2020 with USG report s/o Left Ectopic Pregnancy. (GTB Hospital being Dedicated COVID Hospital that time).
 - Repeat Procedure:-MTP was done by Medical Methods on 24.12.2020and discharged withfollow-up visit advice.

The DISC Members discussed the case in details and it has been found that some relevant & valid documents are further required to clear the claim.

Therefore, all the members of DISC have unanimously suggested that inthis case too, further discussions may held in the next meeting of the Committee in the presence of the Concerned Nodal officer from both the Hospitals, SDNH & GTBH, with all the relevant documents with them in original is support of Sterilization Failure.

Agenda No. 2.- Empanelment of Doctors for Sterilization Procedures

- Total 21 Doctors had applied for empanelment to perform Sterilization Procedures (Mini-lap, Lap. Ligation or both). The Committee members after examining the documents submitted by them and recommended by their HODs, as per the checklist from GOI, have duly approved for the same.
- The list of Doctors empaneled for Sterilization Procedures is annexed under Annexure-A.

Agenda No. 3:- Empanelment of Service Providers (Doctors) for PPIUCD & PAIUCD under performance linked payment plan (PLPP).

- Discussion held regarding the applications & recommendations from GTBH, SDNH & DHAS for empanelment of Doctors for PPIUCD & PAIUCD (total 22 for PPIUCD & 20 for PAIUCD).
- After verification of relevant documents the Committee has approved the Empanelment of 21 Doctors for PPIUCD and 19 Doctors for PAIUCD under Performance Linked Payment Plan.
- Application from Dr Vinika Nimbodia has been rejected by the committee due to lack of valid documents.
