- After the brief round of introduction, Chairperson IDHS Central, Mr. Arava Gopi Krishna, IAS, District Magistrate, Central District enquired about the current status of Family Planning services in the District. He directed all agencies to continue Family Planning services in facilities as well as outreach even during the ongoing COVID-19 Pandamic.
- 2. Empanelment of new doctors for tubal occlusion & PPIUCD was approved by the DQAC committee. He directed all hospitals/CHCs to send empanelment details of all new doctors as soon as possible after their joining. He further stressed that no sterilization procedure will be conducted by non empanelled doctors and all norms of FPIS must be followed point by point.
- 3. All past payments and incentives shall be cleared by all facilities through DBT mode with immediate effect.
- 4. All facilities to provide alternate long acting Family Planning method to those beneficiaries who are denied permanent method in view of COVID-19 Pandamic.
- 5. Family Planning services should be offered to all eligible couples entering the OPDs for any reason.

Achievements in WPD were also discussed. It was further decided to improve Family
planning coverage in field by way of those ASHAs who are visiting households due to
COVID surveys.

The meeting ended with vote of thanks to the chair.
