 - After the brief round of introduction, Chairperson IDHS Central, Ms. Nidhi Srivastava, District Magistrate, Central District enquired about the current status of Family Planning services in the District. She directed all agencies to continue Family Planning services in facilities as well as outreach.
 - 2. Empanelment of new doctors for tubal occlusion & PPIUCD was approved by the DQAC committee.
 - 3. It was decided to improve family planning IEC display in all the facilities so that the programme is visible even during COVID-19 pandamic as family planning services are integral part of every one's life.
 - 4. It was re-emphasized that all procedures done by newly Empanelled doctors shall be monitored by experienced surgeons for first few surgeries.
 - 5. All past payments and incentives shall be cleared by all facilities through DBT mode with immediate effect.
 - 6. Since WPD fortnight is going on, it was directed to strengthen family planning services in all the facilities.

The meeting ended with vote of thanks to the chair.
