At the outset, DPO (RCH), North East District, welcomed the members. After brief round of introduction, the proceeding of meeting started.

The proceeding and decisions are recorded as under:-

- Family Planning Nodal & NSV Surgeon from JPC Hospital asked to conduct Tubectomy and Vasectomy Fixed Day Services (FDS) in the month of March'22. All arrangements for that will be done by DPMU only.

 Both of them refused to conduct the FDS due to non availability of elective O.T., Anaesthetist and designated Staff for FP work is not available. Funds transfer not possible for beneficiaries after surgery due to non availability of manpower for paper work and non functionality of bank accounts.
- For strengthening family planning services in district Private practitioners to be taken in loop. IEC for private hospital will be provided by DPMU only. CDMO, North East District advised to conduct conference with private practitioners regarding this matter. V.C. will be planned soon. Dr. V.K. Goyal is asked to hand hold the RCH Nodal for the same.
- Mrs. Tanuja From World Vision India is not reporting in DQAC as she is left the NGO (World Vision India) proposal for replacement with some other NGO is put by DPO-RCH. Members of DQAC approved the proposal and replacement may be done with World Health Partner, NGO (Govt. Registered) working in district already in Maternal Health & Family Planning.
- Mrs. Sangeeta (PHNO) transferred from JPC hospital so other nomination for nursing personnel is asked from JPC Hospital Family Planning Unit Dr. Monika Bairathi will provide nomination soon.
