Agenda No. 4:- Review of services at the static institutions i.e. Government and Accredited Private/ NGOs

- DPO-RCH presented the performance trend of four Govt. and one Pvt. Accredited Center during 2022-23 & Q1 (2023-24)
- An overall decreasing trend of Sterilization Services has been observed in public hospitals in comparison to LFY (2022-23). Nodals/Representatives from Hospitals informed the committee that an increased acceptance of temporary methods among eligible couples including post-partum women led to this scenario.
- The numerical values of facility-wise sterilization service delivery in the District is placed below:

- The CDMO Shahdara pointed out that improvement in acceptance of temporary methods is good, but these can be discontinued at any time which leads to increase in number of eligible couples with unmet needs and risk of unwanted pregnancy with its consequences.
- There should be adequate & appropriate counseling services to the clients for adopting permanent methods when they are not willing to expand the family more after one or more children.

[Action: FP Nodal Officer, All Hospitals]

DPO-RCH requested the Nodal Officers/Representatives from SDNH & DHAS to expedite the process
of procurement for Laparoscopes. There are recent transfers under ESIC Hospitals and the Hospital
Authority; therefore, IGESIH Jhilmil is requested to share the details of empanelled Sterilization
service providers, if any.

[Action: HOD (OBG), DHAS & SDNH]

- Regarding the referral linkage for histopathology samples (post-minilap) by Dr Hedgewar Hospital, as recommended during last DQAC meeting, Dr Renu Gupta, MO (DHAS), informed the committee that HPE is now available at their hospital.
- As per observations by the DQAC, the **Hysterosalpingography** service at GTB Hospital is still not resumed and the hospital authorities are requested to look into the matter at the earliest.

[Action: MD & HOD (OBG), GTBH]

Other records of discussion are as follows:

- Review of two Sterilization failure cases, as discussed during last DISC meeting held on 12.01.2023, was
 done and the committee recommended closure of the claims for compensation for Failure of
 Sterilization under FPIS, as the claimants have either withdrawn the claim or failed to submit the proof
 of tubal patency as recommended by the DISC.
- DPO-RCH apprised the committee regarding availability of an empanelled NSV Surgeon at the
 Accredited Pvt. Center, PSS Karkardooma since February 2023 and as the Center is also accredited for
 NSV Services, it will be beneficial for many eligible clients, although, deficiency of some instruments
 under NSV Kit, as recommended in the Manual for Male Sterilization 2013, has been noticed during
 facility visit.
- In this regard the committee has recommended that the Accredited Pvt. Center must assure
 availability of all the suggested instruments under the kit and avail District's nod before initiating NSV
 services.

 [Action: Clinic In-charge, PSS, Karkardooma Clinic]
- The committee further suggested the Nodal Officers/Representatives from Hospitals to ensure a quality care at every service delivery point, seamless follow-up services and an overall improvement in Sterilization services, especially the interval procedures and NSV services.

The meeting ended with vote of thanks to the Chair.
