EMD deposited in any other form shall not be accepted. Bids submitted without EMD shall be summarily rejected. Validity of EMD is 180 days.
- 2. VAT/Service tax registration certificate self attested.
- 3. The Compony should certify that it has never ever been blacklisted by Govt./Any other organisation.
- 4. Sample of Board/Paper/Leather proposal without sample will not be considered.
- 5. Company should provide the evidence that it has the annual turnover of Rs. 2,00,000 for last three financial year including the work order from Govt. Organisation.

Proposal without the required samples will not be considered.

The Material to be printed shall be supplied by the Department in a CD. The firm must collect the material from the above address and submit a proof copy for approval within five days of receiving the work order. Any corrections / modification / formatting required shall be done by the firm. The final CD used for printing shall be the property of The Tobacco Control Program under Director General of Health Services, Department of Health (GNCTD) and shall be returned by the firm.

The supplies will have to be made strictly in accordance with the approved specifications within 14 days of the issue of confirmed supply order. Supplies, if received later may not be accepted or penalty at the rate 2% per week (maximum upto 10%) of the total amount of bill may be imposed. Failing supply, contract will be cancelled and firm will be blacklisted. However, in exceptional circumstances, extension may be granted by the DGHS.

## **Selection Procedure:**

Selection will be done by the committee constituted for the above said work.

- Scrutiny of Pre-qualification documents.
- Scrutiny of Samples.

**Terms of Payment:** Payments shall be made by the Ordering organization within 15 days from the date of complete delivery of the material ordered after satisfactory supply of all the Challan Book ordered along with invoice Bill (in triplicate). Tax at source will be deducted from the amount of bill as per prevailing I.T. Rules. The payment shall be made after deduction of any penalty as prescribed & imposed for breach I violation of any the provisions I terns and conditions of the tender and contract.
