2. All hospitals must accept the claim form even if sterilization procedure has done in other accredited facility.

3. Provision of Male family planning services in the form of dedicated counselling desk to be ensured in all hospitals.

(Action to be taken by MS/FP-Nodal officers)

4. IEC Material consisting of FPIS and service delivery available in concerned hospital to be ensured and prominent places in all accredited hospitals.

(Action to be taken by FP-Nodal officers)

5. NSV Club to be strengthen and frequent meeting to be ensured in all facility.

(Action to be taken by MS/FP-Nodal officers)

6. Consents and post-operative instructions must be explained to all beneficiaries in their local language before signatures.

(Action to be taken by FP-Nodal officers)

7. All Sterilization failure claims must have valid account numbers and Aadhar numbers for transfer of compensation amount.

(Action to be taken by FP-Nodal officers)
