Minutes of Meeting

A meeting of District Quality Assurance Committee (DQAC) - East District under Quality Assurance/NQAS Programme held under the chairmanship of Additional District Magistrate-East District on 28th June 2023 (Wednesday) at 02:30 PM in Conference Hall, LM Bandh, New Lahore Shastri Nagar, Geeta Colony, Delhi-110032.

At the outset, Mission Director IDHS-East District welcome the members, DM/DC (East District) was busy in attending some urgent meeting, owing to which Additional District Magistrate (East District) chaired the meeting, ADM East District represented on behalf of DM/DC East District. After brief round of introduction, the proceeding of meeting started. Power Point presentation given by DPM-ED and DPO (RCH) on following agenda:-

1. Overview of Quality Assurance Programme and Kayakalp Programme.
2. Status of implementation of NQAS and Kayakalp at various Health Facilities.
3. Selection of 5 PUHCs for NQAS Certification in F.Y 2023-24.
4. Vetting of empanelment of Medical Officer (MO) for sterilization/PPIUCD/PAIUCD
5. Sensitization of upcoming WPD Campaign
6. Review the status of DBT under Family Planning (FP) Programme

The proceedings of meeting recorded as under:-

- 1) The details of NQAS and Kayakalp program Operational guideline implemented at Health Facilities was informed to the committee members along with the concept of Quality Services evaluated under dedicated checklists.
- 2) The status report of NQAS and Kayakalp Program as per achieved score by all PUHCs / MHs under East District was shared.
- 3) It was apprised to the members that from East District 5 PUHCs have been selected for NQAS Certification assessment during FY 2023-24. The selected facilities are DGD Geeta Colony, DGD Bank Enclave, DGD New Lahore Shastri Nagar, DGD Mayur Vihar Phase-1 and DGD Trilokpuri.
- 4) It was informed that the Health Facilities under East District are being assessed annually both NQAS and Kayakalp Program. Implementation at various levels i.e for NQAS facility level internal assessment, District level assessment, State level assessment and final certification through National level assessment. As per dedicated checklist/format. Further the Kayakalp program (Part of NQAS) are being assessed / evaluated at Internal Assessment level, Peer Assessment level and External level Assessment. The minimum benchmark for level of assessment of Health Facilities to achieved 70% and more in Each level and final score of Health Facilities lead to Kayakalp Award at State Level. In view of this the members have suggested to put maximum efforts to ensure Quality Services at PUHCs/MHs for Public and to motivate the Health Facilities East District to achieve benchmark score of NQAS and Kayakalp.
- 5) Orientation on Family Planning services and the status report was shared by DPO-RCH. The Physical report in term of temporary method and permanent method of family planning services had been discussed. The achievements under sterilization services for Male (NSV) require special enforces by creating maximum awareness and community mobilisation. In this regard the members recommended for extensive IEC/BCC activity and inter sector participation for male participation in Family Planning and population stabilization.
- 6) The members were apprised on World Population Day campaign-2023 as it is an annual event/campaign focussing on creating maximum awareness among community for availing family planning services and to mobilise the community by promoting Mothers and Child Health. The theme of World Population Day-2023 i.e "आजादी के अमृत महोत्सव में हम लें यें संकल्प परिवार नियोजन को बनाएंगे, खुशियों का विकल्प" was informed along with the phases divided in two parts i.e Mobilization Fortnight (27th June 2023 to 10th July 2023) and Population Stabilization Fortnight (11th July 2023 to 24th July 2023). The discussion held on IEC/BCC activity like distribution of Poster, Banner, Handbill among community and Health Facility along with Mid Media activities like Health Talk, Focused Group Discussion, Nukkad Natak, Munadi etc. to create awareness on Family Planning Services during upcoming event. Further the preparation during population stabilization fortnight was discussed. The activities could be counselling of clients,

condom boxes, distribution of contraceptives, injectable contraceptive service, IUCD services, Key contraceptive messages to all Health Personnel & clients, sterilization services.

- 7) The vetting of empanelled Doctors/Surgeons for PPIUCD, PAIUCD and Minilap sterilization at Hospital as per duly verified documents of LBS Hospital through members of DQAC-Family Planning was presented. The details are as below:-

8) It was informed that under the Maternal Health and Family Planning programme, provision of incentives for beneficiaries and service providers like JSY, PPIUCD, PAIUCD etc. These incentives to be released through DBT mode from District Hospital as per available NHM Fund. However, since April 2022 the payments/DBTs are pending at Hospital level due to non updation /delay in updation of signatory in the SNA account opened with ICICI Bank. In this regard, ADM-East had directed the hospital to expedite the process of signatory updation and to ensure release of pending payments / incentives provisioned under program on urgent basis.
