## Minutes of meeting of District Quality Assurance Committee Meeting (DQAC)

The meeting of District Quality Assurance Committee was held on 28<sup>th</sup> October, 2020 in the Conference hall of the O/o District Magistrate (New Delhi District), 12/1, Jamnagar House, Shahjahan Road, New Delhi – 110001, at 11.30 PM under the Chairmanship of Additional District Magistrate, New Delhi District.

The agenda of the meeting was as follows:-

- 1. To discuss one sterilization failure case of Mrs. Sangeeta w/o Mr. Rajender (Maternity and Gynae R.K Puram)
- 2. Any other issue with permission of chairperson.

The meeting started with welcome address by Dr. Neeta Singla (DNO RCH, NDD), followed by the brief round of introduction of all the members of DOAC, New Delhi District.

The attendance sheet of the members is enclosed.

The following points were discussed:-

- 1. Dr. Neeta Singla (DNO, RCH) informed the committee members about the performance of New Delhi District in sterilization and no case of failure was reported during 2019-20.
- 2. Dr. Neeta Singla( DNO,RCH) apprised DQAC about the empanelment of service provider done during 2019-20 which is as follows:-
  - 35 empanelment done for sterilization
  - 42 empanelment done for PPIUCD
  - 36 empanelment done for PAIUCD
- Case of Sterilization Failure: The case of Mrs. Sangeeta W/o Mr. Rajender was
  discussed in detail. She underwent sterilization operation on 04/11/2019 at
  Maternity & Gynae Hospital, R K Puram (Laparoscopic Tubal Ligation). Her
  pregnancy test came positive on 21/05/2020 and she informed the health facility on
  27/05/2020.
- 4. The committee members after going through the case sheets, came to conclusion that reason of the sterilization failure was slipping of the left fallope ring as during re-surgery fallope ring was absent on left side.
- The Committee member recommended that Mrs. Sangeeta is eligible for the release of compensation amount as per Family Planning Indemnity Scheme.
   The above mentioned case is being forwarded to SPO, Family Planning for reviewing the case for settlement

The Meeting ended with vote of thanks.
