- I. Registration on DSHM Website is mandatory; unregistered candidates will not be allowed to appear for interview.
- II. No TA/DA shall be paid for attending the Interview.
- III. The engagement will be purely on contract basis as per the policy of National Health Mission. The contract is extendable based upon approvals received from Govt. of India and annual performance evaluation.
- IV. There shall be an initial assessment (probation) period of three months from the date of first engagement.
- V. The cut off age, qualification, experience etc. will be last date of registration, i.e **06-11-2025.**
- VI. Relaxation for SC/ST/OBC and Physically Handicapped will be given as per Government guidelines, subject to submission of Caste / Disability Certificate issued by the Appropriate Authority in support of his/her claim.
- VII. OBC Certificate with Non-Creamy Layer issued by appropriate authority of Govt. of NCT of Delhi, only will be accepted & current Financial Year.
